#### **SUMMARY OF REQUEST:**

The level of demand for Infant and Children Medicaid and Health Choice services for children of working families continues to steadily increase. Since FY 2001/2002, Health Choice has increased 102% and Infant and Children's Medicaid 91%. Of particular note is the 37% increase in mail-in applications over the previous twelve months.

Staffing (one full time employee) for Health Choice has not increased since FY 2001/2002. Adjustments through workload reassignments/redistribution do not appear reasonable as an option. Significant level of demand increases is being experienced in all assistance programs, especially Food Stamps.


The request is being made for one (1) additional full-time worker and two (2) part-time workers to be increased to full-time. Funds are available in the Social Services operating budget to cover the increased county cost (\$7394) through the remainder of this fiscal year. Additional county costs for next fiscal year would be \$37,116.

#### **COUNTY MANAGER'S RECOMMENDATION/BOARD ACTION REQUIRED:**


Since these positions require the use of County funds, I am reluctant to support any additional staff based on growth for services during the year without a change in programming. I would suggest that this request should not be approved and then submitted as a part of their Fiscal Year 2005-06 Budget to be considered with their other needs and that of the entire County.

# REASONS FOR GROWTH IN LEVEL OF DEMAND FOR HEALTH CARE COVERAGE SERVICES TO CHILDREN OF WORKING FAMILIES IN HENDERSON COUNTY

- ➤ Loss of manufacturing jobs
  - o Cranston...Steelcase
- ➤ Long Term Unemployment
  - 50% slower job market recovery rate of 2001 recession compared to previous recessions
  - o 9% increase in underemployment
  - o 41% increase in exhausted unemployment benefits (ESC)
  - o Record growth in Blue Ridge Community College enrollment
- Gain of service jobs
- > Decrease in jobs with health care benefits:
  - o 8% decrease since 2001
  - Less than 50% of leisure & hospitality, services, and retail jobs include health care coverage
