# RESOLUTION DECLARATION OF SURPLUS PERSONAL PROPERTY AND AUTHORIZING THE SALE BY ELECTRONIC PUBLIC AUCTION

**WHEREAS,** Henderson County owns personal property itemized on the attached Exhibit B, hereinafter sometimes referred to as "Surplus Property", that is no longer needed for any governmental use by the County; and

**WHEREAS**, the Henderson County Board of Commissioners is desirous of declaring this personal property surplus and selling it at public auction as authorized by NCGS 160A-270: and

**WHEREAS,** it is the intent of the County to sell said surplus property by electronic public auction at <a href="https://www.govdeals.com">www.govdeals.com</a>.

**NOW THEREFORE BE IT RESOLVED**, by the Henderson County Board of Commissioners as follows:

- 1. The personal property itemized on the attached Exhibit B is hereby declared to be surplus property.
- 2. The Finance Director is hereby authorized to sell by electronic auction at <a href="https://www.govdeals.com">www.govdeals.com</a> the surplus property described above to the highest bidder.
- 3. All Surplus Property will be sold "as is", all sales final, cash, certified check or money order only. Henderson County makes no express or implied warranties of merchantability of any Surplus Property, or part thereof, or its fitness for any particular purpose regardless of any oral statements that may be made concerning the Surplus Property or any part thereof.
- 4. A notice summarizing this Resolution and the sale of the Surplus Property by electronic public auction shall be advertised by the Finance Director in the Hendersonville Times-News at least ten (10) days prior to the public auction.
