**RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF HENDERSON COUNTY AUTHORIZING THE DISPOSITION  
OF PERSONAL PROPERTY BY PRIVATE SALE  
AS AUTHORIZED BY N.C.G.S 160A-267**

**WHEREAS**, Henderson County has received a request from APGAR Ambulance L.C. in Laramie, WY to purchase a 2001 E-350 Ford Van Ambulance for \$16,000 that has been declared surplus by the Henderson County Board of Commissioners at their February 6, 2006 meeting; and

**WHEREAS**, the Henderson County Board of Commissioners desire to sell personal property which has been declared surplus and the disposition of personal property by private sale is authorized by N.C.G.S. 160A-267.

**NOW, THEREFORE, BE IT RESOLVED** by the Henderson County Board of Commissioners as follows:

- (1) The Finance Director is hereby authorized to dispose of the aforementioned vehicle by private sale to APGAR Ambulance L.C. located in Laramie, WY at the negotiated price of \$16,000 as authorized by N.C.G.S. 160A-267.
- (2) The Clerk to the Board shall advertise a notice in the local newspaper summarizing the contents of this resolution and no sale shall be consummated until 10 days after its publication.

**§ 160A-267. Private sale.**

When the council proposes to dispose of property by private sale, it shall at a regular council meeting adopt a resolution or order authorizing an appropriate city official to dispose of the property by private sale at a negotiated price. The resolution or order shall identify the property to be sold and may, but need not, specify a minimum price. A notice summarizing the contents of the resolution or order shall be published once after its adoption, and no sale shall be consummated thereunder until 10 days after its publication. (1971, c. 698, s. 1; 1979, 2nd Sess., c. 1247, s. 24.)
