4. Amendments: The N.C. Department of Crime Control & Public Safety, N.C. Redevelopment Center (CC&PS) hereby amends the original approved amount of \$571,050 awarded to Recipient on Dec. 20, 2005. This Amended Funding Approval shall operate as the authorization for the amended grant award. CC&PS may increase the amount of funds approved by further amendment and issuance of a new funding approval.

5. Conditions:

- 1.) All approved CHAF projects must be under bid and under signed written contract to perform the approved relocation, repair, rehabilitation, or replacement by March 1, 2006. All builders, contractors, subcontractors or entities assisting with relocation, performing repairs or providing replacement housing for Recipient must enter into written contracts with eligible homeowners; all such contracts must be approved by the Recipient or its authorized designee. All projects must be completed within 8 months of executing this amended Funding Approval.
- 2.) Monthly and quarterly status reports shall be submitted by Recipient to CC&PS as scheduled.
- 3.) All CHAF funds are subject to, and all expenditures must comply with, the Hurricane Recovery Act of 2005, Session Law 2005-1, the Report of the House Appropriations Committee on The Hurricane Recovery Act of 2005, dated February 17, 2005, the 2005 CHAF Grant Agreement and any subsequent amendments, the state CHAF Administrative Rules at 4 NCAC 19L, the 2005 CHAF Guidelines, all applicable Executive Orders, SARF for Homeowners, Housing Repair and Replacement Assistance Program Disclosure Forms, and all other laws, rules, policies and requirements of CC&PS now or hereafter in effect.
- 4.) In the event of any inconsistency or conflict between the language of this Amended Funding Approval Form and prior Funding Approval Forms, the language of this Amended Funding Approval Form shall be controlling, but only to the extent of such conflict or inconsistency. All other terms and conditions of prior Funding Approval Form(s) shall remain in effect.
- 5.) CC&PS' performance and obligation to pay under the project, grant, Grant Agreement and Funding Approval Form(s) is contingent upon the receipt of funds from the agency or entity funding the CHAF program and approved project, including but not limited to, the Legislature and the State Office of Management and Budget.
