#### **SUMMARY OF REQUEST:**

The 2005 Community Development Block Grant (CDBG) provided for the rehabilitation of up to 8 homes in Henderson County. As with any home repairs, un-anticipated costs are common. It is necessary to reduce the number of homes rehabilitated with this grant from 8 to 5 due to increases associated with electrical repairs, lead paint abatement, and Division of Community Assistance housing rehabilitation guideline changes. With these increases, funds do not exist in the grant to rehabilitate all 8 homes.

A public hearing is required to change the scope of the grant to rehabilitate 5 homes instead of 8. The hearing was advertised in the Times-News on Monday, April 30, 2007. No action is required by the Board other than holding the public hearing.
