#### **SUMMARY OF REQUEST:**

An *Application for Solicitation Permit* has been submitted, requesting that the Board allow petitions to be left in the administrative offices at 100 North King Street and in the County libraries during the months of July and August. The purpose of the Solicitation is "To allow Henderson County citizens to express concern re: recent and future housing development, asking for a moratorium on any developments until after new land use code is in effect."
