Summary of Request:



ENGINEER'S REPORT EDNEYVILLE POST OFFICE WATER MAIN EXTENSION

2. PROJECT DESCRIPTION & INTRODUCTION

This project is located on the north side of US 64 East and approximately 90 feet east of SR 1722 in Henderson County. This water main extension is being done by contractors for the City of Hendersonville's Water and Sewer Department.

This proposed water extension will require tapping into the existing 12" water main on the north side of US 64 East and running east along the north side of US 64 East for approximately 4500 feet. This proposed line will have installed one fire hydrant with appropriate tee's, valves and fittings.

3. DESCRIPTION OF FUTURE SERVICE AREAS

This extension will serves the existing Edneyville Post Office with 3 employees. Existing lines are adequate for serving surrounding areas.

4. PRESENT AND ANTICIPATED WATER DEMANDS

Present water demands are to serve the 3 employees in the existing Post Office. Thus the design demand is approximately 3 employees @ 20 GPD/connection. Total demand is approximately 60 GPD.

5. CHARACTER OF THE SOURCE SUPPLY

The water supply for this project is from the City of Hendersonville Water Treatment Plant.

6. AGGREEMENTS TO PURCHASE WATER

7. USEFUL LIFE OF FACILITIES

The useful life of the water lines for this project is expected to be 50 years minimum.

8. MAXIMUM DAILY TREATED WATER SUPPLY AND MAXIMUM DAILY DEMAND

The maximum daily treated water supply for the City of Hendersonville water plant is 12MGD. The average demand is 7.2 MGD, with a daily peak (for the year) of 9.5 MGD

9. IDENTIFICATION & DESCRIPTION OF THE SERVICE AREA

The initial service area for this project is approximately 1 Post Office with 3 employees.

Fire Protection will be provided by the installation of 1-fire hydrants.




