### **Summary of Request:**


The City of Hendersonville has requested that the County comment on the proposed water line extension for the Vistas at Champion Hills. The proposed water line is 1640 linear feet with three (3) fire hydrants. The project's location within the Urban Services Area is consistent with the Henderson County 2020 Comprehensive Plan. #### **ENGINEERING REPORT**

Water Line Extension to Serve Vistas at Champion Hills Henderson County, North Carolina February 19, 2008

The proposed project is located on Willow Road across from Indian Cave Road which is in the Champion Hills Club property in southwest Henderson County. The proposed project is an extension of the existing public water distribution system owned and maintained by the HENDERSONVILLE WATER & SEWER DEPARTMENT. The project will include the extension of approximately 864 lf of 8" and 776 lf of 6" ductile iron waterline pipe and related appurtenances to serve a 20 unit condominium complex located on the south side of Willow Road. Three (3) fire hydrants and other related appurtenances will be installed. The proposed extension will be completed in one (1) phase.

The proposed extension will tie to the existing valve on the existing publicly owned 8" water main located along the north side of Willow Road. The total estimated water use for the subdivision is approximately 6000 gpd, with an anticipated peak water usage of approximately 25 gpm. The proposed project is currently owned and is being developed by:




