#### **SUMMARY OF REQUEST:**

On December 1, 2008, the Board of Commissioners approved the purchase of six (6) Sheriff's Department Patrol Vehicles and directed that bids be obtained. Formal bidding was conducted by Sheriff's Department personnel between December 5<sup>th</sup> and December 12<sup>th</sup>, 2008. The lowest, responsive bidder for six (6) 2009 Dodge Chargers was Ilderton Dodge at \$21,547 per vehicle for a total of \$129,282. The Board is required to approve the lowest responsive bidder in a formal bidding process.

Since the number of patrol vehicles approved for purchase is far less than the original number anticipated, Staff is requesting approval of the attached budget amendment to move budgeted debt service funds to the Sheriff's Department to pay cash for the vehicles instead of financing as previously planned for a larger number of vehicles for multiple departments.

#### **BOARD ACTION REQUESTED:**

The Board is requested to accept the low bid, authorize the Sheriff's Department to purchase the vehicles and approve the attached budget amendment.

#### **Suggested Motion:**

I move the Henderson County Board of Commissioners accept the low bid from Ilderton Dodge for the purchase of six (6) 2009 Dodge Charger, authorize the Sheriff's Department to make the vehicle purchases and approve the attached budget amendment for funds necessary to pay cash for the vehicles.
