## **SUMMARY OF REQUEST:**

Cooperative Extension has requested that their 4-H Program be permitted to use the Curb Market parking lot, which the County currently has leased, during the Apple Festival. The 4-H Program wishes to use this lot to charge for parking as a fundraiser for their program. The group has used the parking lot in this capacity in years past, but staff felt it prudent to bring to the Board of Commissioners given the recent execution of a contract with the Curb Market.

Staff recommends that the 4-H Program be permitted to use the Curb Market parking lot for their requested purpose during the Apple Festival for the hours designated in the County's lease agreement with the Market.

#### The lease contains the following:

3. Lessee, its elected or appointed officials, agents and employees, and persons who are parking while on business with the Lessee (including but not limited to attending or scheduling meetings or appointments with or of the Lessee, its boards, committees, elected or appointed officials or employees, and attending exhibitions of the Lessee or its tenants, such meetings, appointments and exhibitions collectively referred to here in as "Events"), and others with the Lessee's express permission, shall be entitled to use the parking area during times when the Lessor is not operating "The Curb Market", but in any event the following times: all day on Sundays, Mondays, Wednesdays, and Fridays of each week; and, such times after the close of The Curb Market (but in any event after 4:00 p.m.) on Tuesdays, Thursdays and Saturdays of each week.

Under the lease (signed 2 February 2009), we control its operation all day on Sundays, Mondays, Wednesdays and Fridays, plus after the Curb Market closes on Tuesdays, Thursdays and Saturdays. However,

10. During special events involving festivals in downtown Hendersonville, the Lessee may, at its sole option, allow public or charitable groups to use the leased premises to rent out to the public for parking. Notwithstanding, however, no such public parking, or any other use by the Lessee or at its discretion, shall be allowed during the periods in which the Lessor is operating The Curb Market.

So the Board of Commissioners (or you, if they allow) can permit 4-H to operate the parking on Friday, Sunday and Monday, and <u>after the Curb Market closes</u> on Saturday. Usually that's by 2:00 p.m. (I think Ms. Knapp meant 2:00 p.m. in her memo, not 2:00 a.m.; I don't think they'll have that much business parking people at 3 in the morning), but they need to get approval from the Lessor/Curb Market as to the Saturday starting time.
