#### **SUMMARY OF REQUEST:**

The Board of Commission appoints: (a) a lead agency to administer the Community Alternatives Program for Disabled Adults (CAP-DA); and, (b) provides the NC Division of Medical Assistance (DMA) a letter of designation with effective date.

Weighing the following strengths, Park Ridge Hospital is recommended for appointment as Henderson County's CAP-DA lead agency:

- Mission includes community service development and outreach services
- Large, stable hospital with extensive medical resources and service depth
- Active participation and leadership in community-based services to elderly and disabled, including Partnership for Independent Living, Health Aging Coalition, and Home and Community Care Block Grant Committee
- Medicaid procedure and billing expertise and established working relationship(s) with state and county Medicaid office(s)
- Home health provider
- Capacity to directly contract with NC DMA and handle all transitional arrangements and requirements with Pardee and NC DMA

## **BOARD ACTION REQUESTED:**

Appointment of Park Ridge Hospital as lead agency to administer Henderson County's CAP-DA Program.

#### **Suggested Motion:**

I move Park Ridge Hospital be appointed as CAP-DA lead agency for Henderson County and a letter of designation be sent to the NC Division of Medical Assistance with the effective date of July 1, 2009.

On April 23, 2009, Pardee Hospital gave NC DHHS a 30-day notification of intent to terminate contractual responsibilities as the lead agency for the Community Alternatives Program for Disabled Adults (CAP-DA) services in Henderson County (Attachment I). Pardee Hospital notified the County Manager's office on April 24, 2009 of this decision.

Social Services staff assisted the County Manager in the planning process of assuring no disabled adult in Henderson County has a disruption in service during the transition to a new service provider.

# Appointment of Lead Agency for CAP-DA:

NC Division of Medical Assistance (DMA) administers the CAP-DA program at the state level. County Board of Commission appoints a "lead agency" to administer the program on the local level. The following agencies may service as lead agency:

- County Department of Social Services
- County Health Department
- County Aging Department
- County Hospital

Lead agencies across the state include forty-four (44) departments of social services, twenty-five (25) hospitals, seventeen (17) health departments, and fourteen (14) aging departments. In seven (7) counties, the lead agency contracts with another provider.

DMA's perspective is contracting out a lead agency should only be a last resort if there are no other agencies in the county who want to operate the CAP/DA program.

#### What is CAP-DA?

The Community Alternatives Program for Disabled Adults (CAP-DA) is a federal program for Medicaid eligible adults (age 18 and older) to remain in their private residences who would otherwise need institutionalization. A doctor must certify institutionalization level of care is needed.

Eligible individuals include those who:

- Live in a private residence and are at risk of being placed in a nursing facility (or live in a nursing facility and desire to return to a private residence);
- Require nursing facility care (intermediate or skilled-level nursing care);
- Need CAP-DA services to remain safely at home;
- Can have his or her health, safety, and well-being maintained at home within the Medicaid cost limit; and
- Desire CAP-DA services instead of institutional care.

The total cost of CAP-DA home care must be within a monthly cost limit. The cost limit is 90% or less of the average cost of nursing home care.

#### CAP-DA services include:

- Case Management Services (a case manager helps coordinate services, provides information and arranges for community resources);
- In-Home Aide Services
- Medical equipment and supplies
- Home mobility aides (wheelchair ramps, grab bars, handheld showers & safety rails)
- Preparation/delivery of meals
- Respite care
- Telephone alert
- Adult Day Health Services (care of adults who need a structured day program of activities and services with nursing supervision)
- Regular Medicaid services (nursing visits, physical therapy, occupational therapy, speech therapy, and home health aid)

The process for recommendation(s) includes:

- Contact(s) with DMA
- Contact(s) with four (4) Henderson County agencies that could serve as lead agency (Health Department, Park Ridge Hospital, Department of Social Services, and Council on Aging)
- Contact(s) with Pardee Hospital
- Contact(s) with Families Together, Inc. (regional CAP provider)
- Review of available DMA and CAP-DA documents
- Face-to-face interviews with interested agencies

# Continuity of Services for Disabled County Residents/Transition:

Though the April 24, 2009 Pardee letter of termination states termination of services on June 1, 2009, Pardee has verbally committed to both DMA (Pamela Howard) and Department of Social Services staff continued administration of the CAP-DA program past June 1, 2009 to:

- Prevent an interruption in service
- Allow time for transition, including: appointment of new lead agency by the Board of Commission and approval of the new lead agency business plan by DMA

#### Recommendation:

# Park Ridge Hospital Strengths:

- DMA preference for lead agency providing direct services (rather than lead agency subcontracting indirect services)
- Large & stable hospital with medical resource and service depth
- Mission of Park Ridge Hospital includes community service development & outreach
- Active participation on Health Aging Coalition and Home & Community Care Block Grant Committee; Formal partner with Council on Aging and Department of Social Services in Henderson County's Partnership for Independent Living
- Medicaid policy, procedure and billing expertise
- Established working relationship with Medicaid eligibility determination staff (Medicaid staff on-site at Park Ridge)
- Capacity to handle all transitional arrangements and requirements with Pardee & NC Division of Medical Assistance

# Director's Perspective:

Park Ridge Hospital self-initiated a letter of intent based on interest in (a) servicing the target group; and, (b) for elderly and disabled community outreach (Attachment II). Park Ridge states CAP-DA "fits in our new partnership with the Henderson County Partnership on Independent Living".

Adding the stated DMA preference that subcontracting be an option of last resort to the strengths of Park Ridge Hospital listed above, Park Ridge Hospital appears a solid recommendation.
