SUMMARY OF REQUEST:

The Board is requested to approve the low bid and authorize the Sheriff to proceed with purchasing 10, Model Year 2010, Dodge Chargers. Bidding was conducted between August 17th and August 21, 2009. The low bidder is Ilderton Dodge at \$21,390 per vehicle, for a total of \$213,900. The vehicles were approved in the Sheriff's Office FY10 budget. The vehicles meet the County Vehicle Replacement Plan (and energy conservation) criteria.

The Board is requested to accept the low bid and authorize the Sheriff to proceed with the purchase.

I move the Henderson County Board of Commissioners accept the low bid from Ilderton Dodge for 10 Dodge Chargers and authorize the Sheriff to make these purchases.

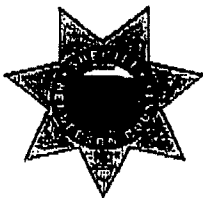
Notes:

- A Public Notice seeking bids appeared in the Hendersonville Times-News from Monday, August 17, 2009 through and including Friday, August 21, 2009
- The bid package was proactively sent to 12 Dodge Dealers, 11 were within a 50 mile radius and the 12th was Ilderton Dodge in High Point, NC....State and Henderson County low bidder for several years.
- Only 2 dealers submitted bids. This low response is typical of past years. The low bidder is Ilderton Dodge
- The total cost, including tax, title and tag (3% Highway Use Tax) of \$632 per vehicle, is $\$213,900 + \$6320 = \$220,220$. The amount budgeted for this purchase was \$23,950 per vehicle for a total of \$239,500. Therefore, the bid is \$19,280 below the budgeted amount including tax, tag and title.
- The bid includes delivery of the vehicles to Central Services, 320 Williams St, Hendersonville
