SUMMARY OF REQUEST:

The Board is requested to approve the low bid and authorize the Emergency Services Director to proceed with purchasing 2, 2009 Chevrolet Type III ambulances. Bidding was conducted between August 12th and August 28, 2009. The low bidder is Southeastern Emergency Vehicles. The lowest bid was \$111,534 per vehicle, for a total of \$223,068. The vehicles were approved in the Emergency Medical Services FY 09-10 budget. The plans are to finance the purchase of these 2 ambulances over a three year term.

The Board is requested to accept the low bid and authorize the Emergency Services Director to proceed with the purchase.
