SUMMARY OF REQUEST:

The Sheriff's Department is requesting that the Board authorize the department to surplus two Sheriff's Office patrol vehicles, transfer them to Blue Ridge Community College (BRCC) and sell the associated vehicle equipment to BRCC for \$8,000. The vehicles and associated equipment would be used by BRCC for their Basic Law Enforcement Training (BLET) Program. The \$8,000 would be applied to new (replacement) equipment for application on FY10 vehicle purchases.

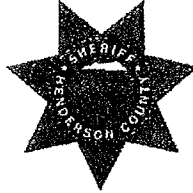
BOARD ACTION REQUESTED:

The Board is requested to approve the request and authorize the Sheriff to proceed with the transfer and sale.

SUGGESTED MOTION:

I move the Sheriff and the County Manager be authorized to surplus two Sheriff's Office patrol vehicles and transfer them to Blue Ridge Community College (BRCC); the associated equipment shall be sold to BRCC for \$8,000; and the Sheriff shall apply the \$8,000 toward new equipment for approved FY10 patrol vehicle purchases.

Dear Mr. Whitson,

In an effort to support Blue Ridge Community College's Basic Law Enforcement Training program, the Henderson County Sheriff's Office would like to assist in upgrading your fleet of BLET training vehicles.

The vast majority of law enforcement vehicles operated by entry level officers today are Dodge Chargers and Chevrolet Impalas. Within a few years they will probably be predominantly Chargers. As new offerings in police vehicles arrive, I'm sure that the trend will continue to change.

It is in the best interest of the Sheriff's Office to hire your BLET graduates who have trained in vehicles similar to those in our fleet.

I propose to transfer two of the cars which we are taking out of primary service, but are mechanically sound, to BRCC which are fully equipped to meet the requirements for delivery of BLET, in exchange for the cost of replacing this required equipment (blue lights, siren, public address system, radio programmed to the BLET frequency) on two replacement cars which are being purchased for my agency. Transferring these cars while equipped will eliminate my cost of removing and then reinstalling the equipment and then BRCC paying to have similar equipment installed in the cars.

At the current rate, this cost will be \$4,000 per car, for a total cost to you of \$8,000. This will allow you to get two fully equipped cars for two thirds the cost of only one surplus NC Highway Patrol car which will not have any equipment.

Acceptance of this offer does not obligate you to any future transfer of equipment, but if your budget and my budget allows for it in future years, I would like to do this annually to keep your training cars relevant to the vehicles my new employees will be actually working in.
