SUBJECT: Approval to purchase a Dodge Ram 2500, pick up truck.

ATTACHMENTS: Quotation from Egolf Motors

SUMMARY OF REQUEST;

Firearms training and qualification has become an increasing problem due to the lack of ranges that will rent their facilities to law enforcement and at the times that are needed. This results in traveling considerable distances. A large, enclosed, secure trailer is used to transport ammunition, firearms, targets, etc. The current sport utility vehicle will not pull the weight of the trailer. This is a request to purchase a diesel, pick up truck for this function. This will be a replacement, not an addition. Earlier in FY10 competitive bids were obtained for a similar truck for Animal Enforcement. Egolf Motors will provide another, identical truck for the same price, which complies with state laws and eliminates the need for another bid process. The Sheriff's Office is projected to be \$284,000 under budget for FY10 with the purchase of this truck accounted for.

BOARD ACTION:

The Board is requested to approve the request and authorize the Sheriff and County Manager to proceed.

Suggested Motion:

I move the Sheriff and County Manager be authorized to purchase a Dodge Ram 2500, diesel pick up truck like the one purchased earlier this year for Animal Enforcement.
