ARTICLES OF INCORPORATION NONPROFIT CORPORATION

Pursuant to §55A-2-02 of the General Statutes of North Carolina, the undersigned corporation does hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation.

1.	The name of the corporation is The Henderson County Agriculture Development and Assistance Corporation.

- 12. These articles will be effective upon filing.
- 13. Prohibited Activities: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in these articles of incorporation. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(6) of the Code.
- 14. Distributions Upon Dissolution: Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively to the County of Henderson, North Carolina, to be used exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located to such government for such purposes.
- 15. Board of Directors: There shall be eleven (11) directors of the corporation, who shall be elected by the Board of Commissioners of Henderson County on the basis set forth in the attached Exhibit A, which is incorporated herein by reference.
- 16. Modification. These Articles can only be modified by vote of the Board of Commissioners of Henderson County.

EXHIBIT A - Board of Directors

Number: There shall be eleven (11) directors of the corporation, all of whom shall reside within Henderson County.

<u>Election</u>: The directors of the corporation shall be elected by the Board of Commissioners of Henderson County.

<u>Seats</u>: The directors of the corporation shall hold designated seats, with such designations denoting both the category of eligibility from which each director is elected, and the term of each director. The designations are as follows:

<u>Term</u>: Each director's term after the initial term set forth above shall be three (3) years. All terms shall end on the 30 day of June of the year in which it ends.

<u>Succession</u>: Each director may serve a maximum of two (2) consecutive terms, not including the initial term.

<u>Responsibilities of the Board</u>: The board of directors of the corporation shall have the following responsibilities, in addition to the other duties of such a board in a North Carolina non-profit corporation:

- 1. Electing a chair and a vice chair from its membership.
- 2. Selecting and employing a president/chief executive officer.

- 3. Establishing and maintaining the corporation's status under Section 501(c)(6) of the Internal Revenue Code of the United States of America, or succeeding similar statutory provisions.
- 4. Adopting and enforcing by-laws not inconsistent with the Articles of Incorporation and any Amendments thereto.
- 5. Filing a written report summarizing the activities of the Corporation with the Board of Commissioners of Henderson County on a monthly basis.

<u>Ex officio Status of Henderson County Commissioners</u>: Any commissioner or commissioners selected by the Board of Commissioners of Henderson County may sit as a non-voting member of the board of directors. However, should a sufficient number of Commissioners attend a board meeting such that the "Open Meetings" provisions of North Carolina's General Statutes apply, such provisions shall be fully honored.
