Whereas,	the American Cancer Society is a national organization that generates funds for new research, education, advocacy, and patient services in the fight against cancer; and
Whereas,	Relay For Life is the signature fundraiser for the American Cancer Society in which 3.5 million people participate each year nationally; and
Whereas,	the purpose of Relay For Life is to Celebrate the lives of those who have battled cancer, remember loved ones lost to the disease, and to fight to end cancer; and
Whereas,	the 2011 Henderson County Relay For Life will take place at WNC Agricultural Center School on May 20 to May 21st; and
Whereas,	each year hundreds of Henderson County residents join in teams to raise thousands of dollars for the American Cancer Society culminating in a night full of activities, games, entertainment and recognition of those who were touched by this disease; and
Whereas,	one-third of Americans will be diagnosed with cancer during their lifetime and because of the fundraising efforts of Relay For Life the survival rate from the disease is 62%; and
Whereas,	in 2010, 210 Henderson County residents obtained services and assistance from the American Cancer Society; and
Whereas,	285 Henderson County citizens who are cancer survivors celebrated in Henderson County's 2010 Relay For Life; and
Whereas,	the Henderson County Relay For Life celebrates the lives of cancer survivors, remembers those who were lost to the disease and raises money to support the fight against cancer;
NOW, THEREFORE BE IT RESOLVED by the Henderson County Board of Commissioners, that May 20 – May $21^{\rm st}$ , 2011 be designated RELAY FOR LIFE Day in Henderson County, and encourages citizens in Henderson County to take an active role in the fight against cancer.
