Congratulations! I am writing on behalf of the Board of Trustees of the Clean Water Management Trust Fund (CWMTF) to advise you that the Board approved funding for Rance Henderson the subject grant up to \$96,000 to protect and restore surface water quality at its October 11, 2010 meeting.
