SUBJECT:	Henderson County Boards and Committees

At its meeting on July 20, 2011, the Board requested staff to prepare a study regarding existing Boards and Committees. In accordance with this request, attached is a summary resultant from this study along with information regarding risk identification and classification concerning each Committee. This Memo will explain the layout of the summary as well as some of the methodologies used to produce the study.

The summary includes the following information:

- The Name of the Committee and the number of members appointed by the Board of Commissioners. Please note that the Committee may be comprised of additional members, however *only the number of members that are Board-appointed are included in the spreadsheet*;
- Whether or not the Committee is required by statute, along with the number of members required by statute (if dictated by statute);
- The Committee's purpose or mission as identified in its Charter;
- Notable statutory constraints;
- Assessed risk for each Committee and reason code for the risk assignment. This section is explained in further detail below;
- A section to be utilized by each member of the Board of Commissioners to indicate their preference regarding the disposition of each Committee. Options in this section include (1) Abolish the Committee; (2) Combine the Committee with another Committee having similar objectives; (3) Reduce the Committee's Board-appointed members; (4) Increase the Committee's Board-appointed members; and (5) Allow the Committee to function in its present state; and
- A section entitled "Staff Recommendation", which is provided with assistance from the County Attorney after consideration of statutory requirements and the Committee's purpose and mission per its Charter.

For your convenience, the list of Committees included within this summary has been sorted and color-coded, using the following categories:

- 1. (Pink): Committees required by statute;
- 2. (Blue): Committees required by Henderson County Ordinance but not by statute;
- 3. (Green): Joint Committees and/or Committees governed by other entities (Henderson County appoints members for participation only);
- 4. (Yellow): Committees that serve in an advisory capacity; and
- 5. (Purple): Special Required Financing Authorities.

The attached document entitled "Henderson County Boards & Committees: Risk Identification and Classification" categorizes each Committee as either "High Risk" or "Medium to Low Risk", based on the degree of responsibility empowered to each Committee according to its mission and/or purpose. The first table in this document defines the criteria used to establish each Committee's ranking as either "High Risk" or "Medium to Low Risk" and each set of criteria is numbered, representing a "Risk Code". Hopefully this procedure will serve to answer any questions that may be raised with regard to the various Committee responsibilities and the associated reason for the risk classification.

The consideration of risk it is important with regard to our Boards and Committees in order to ensure proper management of the appointments and provide an overall "big picture" understanding of the various Committees that are appointed by the Board.

According to the Risk Classification, there are currently 25 Committees considered "High Risk" and 35 Committees considered "Medium to Low Risk". According to the Staff Recommendations, it appears that the Board may wish to consider the abolishment 9 of these Committees; the combination of 8 other committees; and a reduction in membership of 2 committees.
