The Animal Ordinance and the Noise Ordinance allow for enforcement in the incorporated areas of Henderson County. To do this, the municipality must request enforcement and the Board of Commissioners must consent to the request. Recently, Henderson County has received requests from every municipality in Henderson County for enforcement of these two Ordinances.

The municipalities have passed resolutions adopting these ordinances to ensure consistency across Henderson County in the areas of animal and noise regulation and requesting enforcement from the County. All of the resolutions are included herein.

County staff will present further information on this matter and will be available to address any questions or concerns this Board may have.
