SUMMARY OF REQUEST:

The Board is requested to approve the low bid and authorize the Sheriff to proceed with purchasing 10 Dodge Chargers, model year 2012. Bidding was conducted between September 29 and October 6, 2011. The low bidder is Egolf of Hendersonville for a total of \$222,190.00 (see attachment 1).

The Board is also requested to approve the low bid and authorize the Sheriff to proceed with purchasing two Chevrolet Tahoes, model year 2012. The low bidder is Asheville Chevrolet for a total of \$61,102.40 (see attachment 2).

All vehicles were approved in the Sheriff's Office FY 2012 budget, and all vehicles meet the County Vehicle Replacement Plan (and energy conservation) criteria.

BOARD ACTION REQUESTED:

The Board is requested to accept the low bids from Egolf of Hendersonville and Asheville Chevrolet, and authorize the Sheriff to proceed with the purchases.

Suggested Motion:

I move the Henderson County Board of Commissioners accept the bids from Egolf of Hendersonville for ten 2012 Dodge Chargers, and from Asheville Chevrolet for two Chevrolet Tahoes, and authorize the Sheriff to proceed with the purchases.

SCOPE: FULL SIZE, DODGE CHARGER OR SUBSTANTIALLY EQUIVALENT, REAR-WHEEL DRIVE:

- 10- New 2012, four door sedan, rear wheel drive, five passenger, EPA large size, with police package.
- 2. Frontal crash rating of five stars from NHTSA.
- 3. Air Conditioning, factory installed.
- 4. Alternator, 220 amp rating.
- 5. Battery, heavy duty 12 volt, mfr's standard except minimum 800 CCA, maintenance free.
- 6. Electronic stability program with brake assist and all speed traction control.
- 7. Brakes: four wheel disc with anti-lock braking system.
- Cooling system, heavy duty, automatic coolant recovery system with permanent type anti-freeze
 protected to -20 degrees F with rust inhibitor. Include silicone or EPDM type hoses.
- 9. Clock, dash mounted, in radio.
- 10. Differential, heavy duty.
- 11. Power window, all four doors.
- 12. Power locks, all four doors with operator override for rear door locks.
- Engine, 8 cylinder, 370 HP, 5.7-Liter HEMI Multi-Displacement, including police package. EPA gas mileage rating of at least 16 City and 25 Highway.
- 14. Rear wheel drive.
- 15. Floor covering, black carpet, heavy duty with removable floor mats.
- 16. Truck to include full carpet covering.
- Dome light in center of ceiling. Dome light door switches deactivated. White and red LED map reading light, mounted on ceiling between sun visors and controlled by a separate switch adjacent to light.

- 32. Seats: Rear fixed bench type. Front cloth buckets, with driver side 6 or 8-way power adjustable. Front seat cloth covering must be intended for heavy duty use. Rear seat, vinyl, colored same as front seats.
- 33. Seat belts and shoulder harnesses: Attachment to door is not acceptable.
- 34. Speedometer, certified calibrated speedometer (2 MPH increments) 3% accuracy.
