**SUBJECT:** Pawnbrokers License for Daily Dollar Pawn, LLC/Bobby Hylemon

**PRESENTER:** Charles Russell Burrell

#### **SUMMARY OF REQUEST:**

Bobby Hylemon has applied, on behalf of Daily Dollar Pawn, LLC, for a license under your pawnbrokers ordinance, Chapter 134 of the Henderson County Code. He has supplied documentation required by the ordinance, with the exception that he has not provided a "certificate from the Sheriff . . . or the State Bureau of Investigation" that neither the petitioner or owner of the business has been convicted of a felony. He has presented a criminal record check from the Henderson County Clerk of Court showing no felony convictions. Neither the Sheriff nor the SBI make available such record checks at the present time.

County staff will be present and prepared if requested to give further information on this matter.

#### **BOARD ACTION REQUESTED:**

License approval.

I move that the Board grant a Henderson County pawnbrokers' license to Daily Dollar Pawn, LLC, and its applicant, Bobby Hylemon.

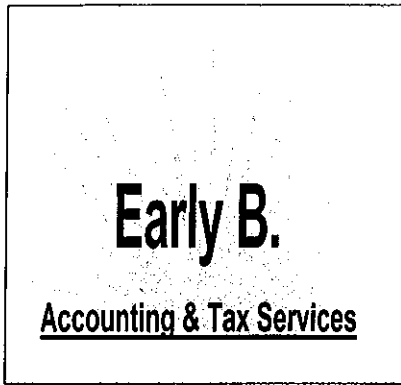

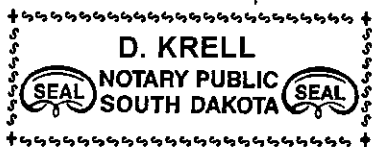
