The Henderson County Board of Commissioners met for a regularly scheduled meeting at 9:00 a.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville

CALL TO ORDER/WELCOME

Chairman Thompson called the meeting to order and welcomed all in attendance.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the American Flag was led by Commissioner Young.

INFORMAL PUBLIC COMMENT

- 1. Alan House Mr. House, Chief Financial Officer of Pardee Hospital, is concerned with the building at the corner of 6th and Justice Street. He is under the impression that it is going to be an ICE detention building, a Federal facility processing illegal aliens. Mr. House noted the property in that area has restricted covenants allowing only professional (medical) offices. A chain-link fence has also been erected which is against the covenants. This facility should be located in a different area.
- 2. Janice Parker Ms. Parker spoke in regard to the Mud Creek Watershed Program. She feels rain gardens are new with very little proven data. She questioned how homeowners will be chosen. Ms. Parker asked that the Board not approve the request.
- 3. Glen Englram Mr. Englram spoke in regard to the Mud Creek Watershed Program. He feels Henderson County is not represented in the Grow WNC Organization or Mud Creek Watershed Council by Land-of-Sky. The properties being proposed for stream restoring are urban and properties rights need to be protected. Mr. Englram asked the Board not to support the program.
- 4. Jane Billelo Ms. Billelo spoke in regard to the Mud Creek Watershed Program. It is now shifting from agricultural to urban. She is against the project and feels it does not protect our property rights. The Federal Government is not elected officials and they will make demands jeopardizing private property rights. Ms. Billelo requested that the Board not support the project.
- 5. Michelle Cassone Ms. Cassone is the CEO of the Elks Lodge, located near the ICE building. She feels it should be located somewhere else.
- 6. Karen Rhoads Ms. Rhoads asked that the Board not to be a part of Land-of-Sky activities as she feels it is not in the best interest of Henderson County citizens.

Tax Collector's Report

Tax Collector Clerk Kathy Johnson had presented the Tax Collector's Report to the Commissioners dated May 9, 2012 for information only. No action was required.

Pending Releases & Refunds

The pending releases and refunds provided in the agenda were reviewed by the County Assessor, and as a result of that review, it is the opinion of the Assessor that these findings are in order. Supporting documentation is on file in the County Assessor's Office.

These pending release and refund requests are submitted for the approval by the Henderson County Board of Commissioners.

Motion:

I move the Board approves the Combined Release/Refund Report as presented.

New Ambulance Financing

A request was made and approved by the Commissioners at the regularly scheduled March 21, 2012 Board meeting to purchase two (2) new ambulances to replace two being leased and due to expire at the end of the current fiscal year. The purchase of the new ambulances is to be financed through a bank installment financing contract at a fixed interest rate with annual payments over a 4-year term.

Staff requested proposals from financial institutions to finance the purchase of the two (2) new ambulances at a total cost not to exceed \$249,378. Attached for the Board's review are the results of the financing proposals that were received from four (4) financial institutions.

BB&T Governmental Finance has been certified as the lowest responsive proposal to finance the new ambulances over a 4-year term at a tax-exempt interest rate of 1.59 percent. The first annual payment of \$64,842.24 will be due in May 2013 and is included in the proposed FY2013 budget.

Motion:

I move that the Board of Commissioners approves the resolution accepting the proposal from BB&T Governmental Finance to finance the new ambulances and authorizing the Chairman and Staff to execute and deliver the required financing documents.

Pawnbrokers License for Daily Dollar Pawn, LLC/Bobby Hylemon

Bobby Hylemon has applied, on behalf of Daily Dollar Pawn, LLC, for a license under your Pawnbrokers Ordinance, Chapter 134 of the Henderson County Code. He has supplied documentation required by the ordinance, with the exception that he has not provided a "certificate from the Sheriff...or the State Bureau of Investigation" that neither the petitioner nor owner of the business has been convicted of a felony. He has presented a criminal record check from the Henderson County Clerk of Court showing no felony convictions. Neither the Sheriff nor the SBI make available such record checks at the present time.

Motion:

I move that the Board grants a Henderson County Pawnbrokers' license to Daily Dollar Pawn, LLC, and its applicant, Bobby Hylemon.

Petition for Addition to State Road system

Staff received a petition to add Bonnie Brae Court to the state road system. It has been the practice of this Board to accept road petitions and forward them to NC Department of Transportation for their review. It has also been the practice of the Board no to ask NCDOT to change the priority for roads on the paving priority list.

Staff reviewed the petition and it appears that all affected property owners or developers have signed the required petition.

Motion:

I move that the Board approves the petition and direct staff to forward it to NCDOT.

Home & Community Care Block Grant: FY2013 County Funding Plan

Each year, the Board of Commissioners is required to adopt a Funding Plan for the Home & Community Care Block Grant for Older Adults and identify the lead office or agency responsible for coordinating the County Funding Plan. The Home & Community Care Block Grant is a State/Federal program administered at the local level. The proposed Funding Plan supports the service priorities identified for the current planning cycle.

At this time, the HCCBG funding for FY2013 is estimated to be \$768,216.

Motion:

I move that the Board appoints the County Manager's office as the Lead Agency and approves the proposed FY 2013 funding Plan.

County Manager Steve Wyatt noted that sales tax is up approximately \$200,000 but trending down. He will continue to monitor.





Mr. Wyatt provided the Board with detailed budget binders and reminded them of the May 22, 2012 budget workshop to be held at 1:00 p.m. and a public hearing on May 29, 2012 at 6:00 p.m.

JUVENILE JUSTICE AND DELINQUENCY PREVENTION GRANTS/JUVENILE CRIME PREVENTION COUNCIL COUNTY PLAN FY 2013-2016

Mary Murray, Chair of J.C.P.C. stated the Henderson County Juvenile Crime Prevention Council (J.C.P.C.) has approved funding for local juvenile crime preventions programs. These funds for Fiscal Year 2012-2013 in the amount of \$193,745 are available for this purpose through the State of North Carolina. Each Program is required to provide a 30% match.

These Grant applications have been recommended for approval to the Board of Commissioners by the Henderson County J.C.P.C.

The Henderson County Juvenile Crime Prevention Council (J.C.P.C.) has approved the 2013-2016 County Plan for Henderson County. This County Plan has been recommended for approval to the Board of Commissioners by the J.C.P.C.

Ms. Murray informed the Board that J.C.P.C. had hired a clerk to Council and a change of bylaws would be coming to the Board's attention in the near future.

Commissioner Messer made the motion that the Board approves the JCPC recommendations for both the FY 13-16 Annual Plan, and the distribution of the FY 2013 Juvenile Crime Prevention Program funds. All voted in favor and the motion carried.

ICE BUILDING UPDATE

Sheriff McDonald provided information on the Federal ICE Building located at 6th and Justice in Hendersonville. Henderson County has nothing to do with the ICE Building, it is a Federal project by Homeland Security for the Homeland Security Agent HUB office and renovations are expected to be completed by the end of June. Homeland Security has rented the property without any consultation with the Sheriff's office. It will be used for administrative workspace only.

Attorney Russ Burrell noted that Henderson County does own adjoining property (Pardee Hospital) and that legislation does require Homeland Security to comply with zoning regulations. He just became aware of the situation today and there is a possibility that Henderson County will be asked to litigate. Mr. Burrell has access to the restricted covenants and will follow up. Mr. Burrell will be contacting the City of Hendersonville and their attorney to see if they had been contacted prior to the anything taking place.

SOCIAL SERVICES' INFORMATIONAL UPDATE

The DSS Board provides monthly three-minute informational updates to the Board of Commissioners regarding various Social Services issues. The May 2012 update, provided by DSS Board member Melinda Lowrance, pertains to the issue of Child Protective Services in Henderson County.

The fourth topic in their series is the role of DSS in the community, and is intended as part of an effort to educate the public and advocate for the state-mandated role of DSS.

Every Henderson County child has the right to be safe. Child abuse and neglect threaten a child's safety by placing the child at risk of physical and emotional harm and even death. Parents have the fundamental and legal right to raise their children and our community presumes parents will protect their children from harm. When parents fail to protect children from the harm of abuse and neglect, our community has a responsibility to intervene to protect the child.

While the true extent of child abuse and neglect is not known in Henderson County, 2500 children were reported to Social Services in 2010-11 by someone in our community alleging the child was being maltreated by their parents. Most reports were from relatives, neighbors, schools, law enforcement, doctors and non-profits. A report is a request to Social Services for an investigation into a suspected incident of abuse or neglect; a report is not necessarily a fact...it is the raising of a question about a child's safety. In order for Social Services to investigate, a report must describe and meet NC Statute legal definitions of abuse or neglect. Of the 2500 children reported in 2010-11, Social Services investigated 1770 children. Investigations are an involuntary intervention with a family and must meet the letter of the law.

Of the 1770 children investigated, 95 were removed from their home by a judge. For up to twelve hours, a DSS worker, doctor or law enforcement officer can remove a child if a child appears in imminent risk of harm; more than twelve hours requires a judge's ruling. The Social Services investigation must have facts to present to the court for a judge to remove a child. I've learned, through my service on the Board of Social Services, that the social worker must also provide proof work was done to prevent the removal. A judge is required by federal law to have findings of fact in the court order that Social Services worked to keep the child(ren) in the home.

Ms. Lowrance stated "I've heard it said if someone (a child advocate or a parent advocate) isn't mad...then DSS is not doing its job. Protecting children is no simple task. In every child protection case, a Social Services worker works with the inherent tension between the child's rights and the parent's rights....balancing child safety and the parent's constitutional rights. I did not know prior to becoming a Social Services Board member that, by law, Social Services must insure both the child's and parent's rights are protected. The law says social workers must insure each child and parent receives services, due process and legal representation. This dual role drives much of the controversy in child protection by DSS".

Over 90% of needs found in investigations are based on neglect, not abuse, and Social Services arranges for or provides services to children and their parents to address these needs. Services are provided without regard to income and may include in-home specialists, day care, parenting/child management classes, mental health services, financial and employment

assistance. Mental health assessments and counseling are provided on-site at DSS, or in the home, by an out posted Families Together, Inc. worker located at the main DSS office. The collaboration with Families Together, Inc. assures timely and quality mental health services for children and parents. Of the 148 children referred to Families Together, Inc., 91% had mental health services started the day of referral.

Since 1998, Social Services has contracted with The Mediation Center (formerly Dispute Settlement Center) to facilitate child and family team meetings. The Board of Social Services believes that social workers have a great deal to contribute to child safety, but important to resolving problems are the families themselves and other community service providers. The Mediation Center facilitated meetings for 330 children (201 parents) in FY 2010-11 in a safe environment so all parties, particularly parents, could be heard and a mutually agreed upon plan made to better address child safety and the family's needs.

In cases involving abuse or serious neglect, the Social Services Board supports multi-disciplinary team staffing at The Healing Place. Bi-weekly meetings, facilitated by The Healing Place staff, are held to establish a dialogue and plan shared by primary protection providers (Social Services, law enforcement and the District Attorney's Office); a medical doctor is also a core participant. In FY 2010-11, 200 new cases were reviewed. Mutual planning between child protection professionals improves decision making, safety outcomes, cooperation between professionals and litigation.

The Board of Social Services wishes to thank our community partners working to ensure Henderson County children are safe. Henderson County has a high number of child abuse/neglect referrals from the community; that means our partners and concerned citizens care and report any suspected abuse or neglect to Social Services in order to keep children safe.

MUD CREEK WATERSHED PROGRAM

Diane Silver, Mud Creek Watershed Coordinator stated the Mud Creek Watershed Restoration project is a consortium of local governments, state agencies, non-profits, and business partners working to protect and improve the quality of Mud Creek and its tributaries through voluntary efforts.

Ms. Silver feels that the grant is a great value to the protection of our resources which draw tourism for the economy. Brittain Creek has been chosen as the focus area for the project. The area suffers from flooding over and over. The urban cost share program will help build bio-retention areas on private property. It is an application process and evaluations will be made by merit. Land owners who accept money will be held accountable for maintenance by contract.

Since 2003, the Mud Creek Project has been hosted by Henderson County Cooperative Extension, funded through grant funds from the Division of Water Quality. The current grant expires December 31, 2012. Applications for funding for 2013 are due May 24, 2012.

Commissioner O'Connor made the motion that the Board does not support submission of the application. All voted in favor and the motion carried.

MOSQUITO CONTROL PROGRAM

The Board is requested to discuss the County's mosquito control program. The program had been in place in the County for a number of years, but was eliminated in the FY12 Budget.

Tom Bridges noted that the budget was reduced and the mosquito program was removed last year. There are some citizens who do not want it such as beekeepers. Even with the program, there will still be some problems in areas of standing water.

Seth Swift stated that IPM is a three (3) tier process:

- 1. Educate public (be aware of property)
- 2. Larva site
- 3. Spray

Jackson Park is treated on a regular basis, other parks and schools if necessary.

Commissioner Young made the motion that the Board authorizes the County Manager to do a budget amendment up to \$40,000 in order to implement the Mosquito Control Program. The motion passed 3-1 with Commissioner O'Connor voting nay.

AMENDMENTS TO THE ANIMAL ORDINANCE

Animal Services Director Brad Rayfield stated at the April meeting of the Animal Services Advisory committee, the Committee unanimously recommended to the Board of Commissioners the amendments including with the agenda to the Animal Ordinance. Most changes were technical in nature. The substantive changes include:

- Clarification of the "Aggressive Dot" language to make it easier for the public to understand and for Law enforcement to enforce;
- Requirement that dogs deemed dangerous/potentially dangerous must be spayed/neutered;
- Inclusion of the reptiles to definition of "Inherently Dangerous Animals";
- Removal of Pet Responsibility Class option under "Penalties and Violations" because it was rarely used and had been abused by violators;
- Revised adoption language for non-profit organizations to encourage non-profit adoption of animals too young or sick to be adopted form the Animal Shelter;
- Removal of written warnings for first violations so now first violations can be presented verbally;
- Addition of language prohibiting frivolous or unfounded complaints to law enforcement.

Chairman Thompson requested that wording be added to Aggressive Animal definitions to include domestic animals while on or off the owner's property.

Commissioner Messer made the motion that the Board approves the draft language to the Henderson County Animal Ordinance with the addition as noted above. All voted in favor and the motion carried,

LDC TECHNICAL CORRECTION – SUBDIVISION DEFINITIONS

Planning Director Anthony Starr stated the Board previously approved a portion of text amendment TX-2010-02 that re-organized the subdivision regulations and added greater flexibility. As part of that re-organization of the subdivision regulations, certain terms were moved from the subdivision section (Article III) to the definition section (Article XIV) of the Land Development Code (LDC). The move of these terms was inadvertently omitted when the Board took action on September 21, 2011.

The text included in the agenda packet was included in the original text considered by the Board during the public hearing November 17, 2010. No additional public notice or hearing is required for action.

Commissioner O'Connor made the motion that the Board approves the resolution of consistency, and further moved that the Board approves the text amendment provided in the agenda to the LDC. All voted

in favor and the motion carried

COUNTY MANAGER'S REPORT

County Manager Steve Wyatt informed the Board that Jackson Park continues to be used as a thoroughfare even with the new design and speed humps. He recommended having law enforcement issue tickets for speeding.

Schedule a Public Hearing for the FY 2013 Rural Operating Assistance Program (ROAP) Application to the North Carolina Department of Transportation

Commissioner Messer made the motion that the Board schedules a public hearing regarding the FY2012 rural Operating Assistance Program grant application for Monday, June 4, 2012 at 5:30 p.m. All voted in favor and the motion carried.

CLOSED SESSION

Commissioner O'Connor made the motion for the Board to go into closed session as allowed pursuant to NCGS 143-318.11 for the following reasons:

- 1. Pursuant to N.C. Gen. Stat. §143-318.11(a)(4), to discuss matters relating to the location or expansion of industries or other businesses in Henderson County, including agreement on a tentative list of economic development incentives that may be offered by the Board in negotiations.

Stat. §143-318.11(a)(6), to consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee; or to hear or investigate a complaint, charge, or grievance by or against an individual public officer or employee.



RESOLUTION APPROVING FINANCING TERMS

WHEREAS, the County of Henderson, North Carolina (the "County") has previously determined to undertake a project for two new 2012 Chevrolet G4500 ambulances (the "Project"), and the Finance Director has now presented a proposal for the financing of such Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF HENDERSON, NORTH CAROLINA, AS FOLLOWS:

- 1. The County hereby determines to finance the Project through Branch Banking and Trust Company ("BB&T"), in accordance with the proposal dated May 4, 2012. The amount financed shall not exceed \$249,378.00, the annual interest rate (in the absence of default or change in tax status) shall not exceed 1.59%, and the financing term shall not exceed four (4) years from closing.
- 2. All financing contracts and all related documents for the closing for the financing ("the Financing Documents") shall be consistent with the foregoing terms. The Chairman and Staff of the County are hereby authorized and directed to execute and deliver any Financing Documents, and take all such further action as they may consider necessary or desirable, to carry out the financing of the Project as contemplated by the proposal and this resolution. The Financing Documents shall include a Financing Agreement and Deed of Trust and a Project Fund Agreement as BB&T may request.
- 3. The Finance Director is hereby authorized and directed to hold executed copies of the Financing Documents until the conditions for the delivery of the Financing Documents have been completed to such officer's satisfaction. The Finance Director is authorized to approve changes to any Financing Documents previously signed by the Chairman or Staff, provided that such changes shall not substantially alter the intent of such documents or certificates from the intent expressed in the forms executed by such officers. The Financing Documents shall be in such final forms as the Finance Director shall approve, with the Finance Director's release of any Financing Document for delivery constituting conclusive evidence of such officer's final approval of the Document's final form.
- 4. The County shall not take or omit to take any action the taking or omission of which shall cause its interest payments on this financing to be includable in the gross income for federal income tax purposes of the registered owners of the interest payment obligations. The County hereby designates its obligations to make principal and interest payments under the Financing Documents as "qualified tax-exempt obligations" for the purpose of Internal Revenue Code Section 265(b)(3).
- 5. The County intends that the adoption of this resolution will be a declaration of the County's official intent to reimburse expenditures for the project that is to be financed from the proceeds of the BB&T financing described above. The County intends that funds that have been advanced, or that may be advanced, from the County's General Fund, or any other County Fund related to the project, for project costs may be reimbursed from the financing proceeds.
- 6. All prior actions of County officers in furtherance of the purposes of this resolution are hereby ratified, approved and confirmed. All other resolutions (or parts thereof) in conflict with this resolution are hereby repealed, to the extent of the conflict. This resolution shall take effect immediately.

WHEREAS, the Planning Director and Planning Board provided recommendations regarding the proposed text amendment with case TX-2010-02; and

WHEREAS, pursuant to N.C. General Statute §153-323, the Planning Director provided the prescribed public notice and the Board held the required public hearing on November 17, 2010; and

WHEREAS, N.C. General Statute §153-341 requires the Board to adopt a statement of consistency with the County Comprehensive Plan (CCP); and

NOW THEREFORE, BE IT RESOLVED by the Henderson County Board of Commissioners as follows:

- That the Board reviewed the proposed text amendment (TX-2010-02 Definitions) and finds that it reasonable, in the public interest and it is consistent with the CCP and the Growth Management Strategy located therein; and
- 2. That the Board determines that the proposed text amendment provides for the sound administration of the LDC while balancing property rights and promoting reasonable growth within the County; and
- 3. That this Resolution shall be retained in the Office of the Clerk to the Board of Commissioners.

Add the following text to Article XIV (Definitions) in alphabetical order:

Conservation Area, Primary. Consists of:


- (1) Floodplains (100-year and 500-year) and hydric soils identified as part of: a Flood Insurance Study prepared by the Federal Emergency Management Agency (FEMA); or the County Soil Survey prepared by the USDA Natural Resources Conservation Service;
- (2) Land located within 50 feet of the bank of any perennial stream; and
- (3) Slopes greater than 30 percent (13.5 degrees) identified as part of: a County Soil Survey prepared by the USDA Natural Resources Conservation Service; or a site analysis conducted by a registered professional engineer, professional land surveyor, landscape architect, architect or land planner and calculated using topographic maps from an actual survey or from the US Geological Society.

Conservation Area, Secondary, Consists of:

- (1) Farmland (whether actively used or not) including cropland, fields, pastures and meadows;
- (2) Natural areas, wildlife habitats and corridors identified as part of: an Inventory of Natural Areas and Wildlife Habitats as prepared by a State agency, the Nature Conservancy or a local land trust; a required Environmental Assessment or Environmental Impact Statement; or an independent site study conducted by a trained botanist or biologist;
- (3) Slopes of 20 to less than 30 percent (nine (9) to less than 13.5 degrees) which require special site planning due to their erosion potential, limitations for septic tank nitrification fields and terrain or elevation changes;
- (4) Historic or archeological sites including, but not limited to, sites listed on the National Register of Historic Places or included on the State's National Register study list, designated as a local historic landmark or district and/or designated as having a high potential for archaeological remains generally identified as part of a: local architectural survey; local archaeological survey; required Environmental Assessment or Environmental Impact Statement; or independent site study conducted by a trained architectural historian or archaeologist;
- (5) Non-commercial cemeteries; and
- (6) Viewsheds (scenic views, especially of natural and cultural features from designated scenic *road* corridors, including "views from the *road*" as well as views outward from potential home sites).

Curve Radius. The distance measured from the centerline of the *road* to a fixed point inside the curve (see Figure 3A. Minimum Curve Radius))
