SUMMARY OF REQUEST:

Attached is a request and supporting documentation for a Rural Center grant to pay for Sewer infrastructure for the Mission-Pardee Hospital project on the Henderson County-Buncombe County line. This grant would be administered and prepared by Martin-McGill and all matching funds would come from The Keith Corporation, owner of the property, there will be no costs to Cane Creek Water and Sewer District. The grant requires that it be submitted by a unit of local government.

The project includes trenching approximately 2190 lf of 8-inch ductile iron sanitary sewer pipe with appurtenances and pavement and curb and gutter repair. The pipe is designed to carry a flow of 5,000 gallons per day to serve the Mission Pardee Health Campus. The total cost of the project is \$550,000 with \$275,000 coming from the grant reimbursement.

SUBJECT: Rural Center Grant to Construct Infrastructure

Marcus,

There is a grant program available from the Rural Center that will support infrastructure construction if there is a commitment of full time jobs that would result. The hospital's consultant is The Keith Corporation. I was asked to brief them on the program and they would like to go ahead with the submission. I believe you are in receipt of a letter from them requesting your participation. However, the application must be submitted by a unit of local government. The unit of local government must supply 5% of the grant amount and the hospital will provide those funds to you. They will also pay my fee for preparing the application. There will be no costs to Cane Creek W & S District. We would need you to participate in a conference call, sign the application and allow the funds to go through the district. In return, you would get a large new customer and new jobs. I have provided some information below on the project:

MISSION/PARDEE HEALTH CAMPUS SANITARY SEWER LINE SERVICE

The project includes trenching approximately 2190 lf of 8-inch ductile iron sanitary sewer pipe with appurtenances and pavement and curb and gutter repair. The sewer line will be laid in the right of way of US 25 (Hendersonville Road), Route 1360 (Hillcrest Rd) and Route 1547 (Old Airport Road). The pipe is designed to carry a flow of 5,000 gallons per day to serve the Mission Pardee Health Campus and the west end of the sewer line will connect to the new Mission Pardee Health Campus, and will connect at the east end to an existing manhole in Jones Road (Town of Fletcher street).

Total project cost would be \$550,000.

If they commit to 28 jobs, they would be eligible for \$275,000 in reimbursement. The local match would be \$13,750 and it would be provided by Mission Pardee.

The first important date would be the conference call and that would need to take place before November 2, 2012.

I am writing as a representative of Western North Carolina Healthcare Innovators who is the Owner of the Mission Pardee Health Campus project on Hendersonville Road in Fletcher.
