I move that the Board approve the petition and direct staff to forward it to NCDOT.


State Road Petition Request Rebels Lair



 Proposed Addition to State Road system

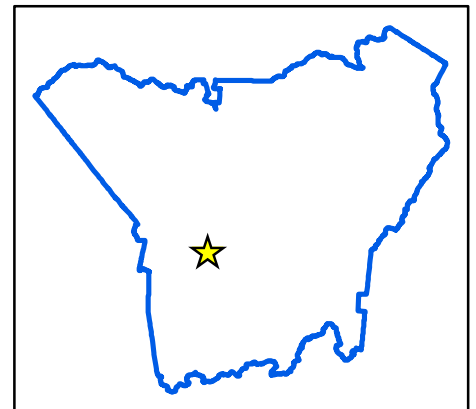
