PROCLAMATION

- WHEREAS, We believe in the unity of our human community and that each individual in Henderson County, regardless of race, ethnicity, religion, age, gender, disability, sexual orientation and economic status is entitled to equal justice, decent housing, adequate health care and equal opportunity for education; and
- WHEREAS, We believe that disregard for human rights results in unfair and unequal treatment and offends the conscience of the community, and that a community in which all individuals enjoy equal respect is the highest aspiration of a society; and
- **WHEREAS,** We further believe in the value of meaningful, honest dialogue and shared activities to promote human rights, relations and responsibilities among the diverse groups in Henderson County;
- NOW THEREFORE BE IT RESOLVED that the Henderson County Board of Commissioners proclaims December 10, 2012 locally as Human Rights Day in recognition of the 64th anniversary of the adoption of the Universal Declaration of Human Rights by the United Nations, and calls upon the citizens of Henderson County to be informed of this Proclamation by causing it to be disseminated displayed and read in public places without distinction.
