#### **SUMMARY OF REQUEST:**

On March 1, 2013 an application for the 2013 Community Waste Reduction and Recycling Grant was submitted to the Division of Environmental Assistance and Outreach for \$12,800 to purchase 26 permanent recycling bins for Jackson and Etowah Parks. By adding recycling bins in Jackson and Etowah Parks Henderson County will be increasing public awareness for recycling in our region. Also, these bins will increase the recycling rate in Henderson County helping to fulfill our goal established in the County's Ten Year Solid Waste Management Plan for a 40% solid waste reduction through improvements to recycling and other programs.

This grant requires matching funds of \$3,199 that will come from the Parks and Recreation budget.

Authorize the County Engineer to sign the contract with NCDEAO for the grant funding of \$12,800 to purchase recycling bins for Jackson and Etowah Parks.

## General Requirement Statement of Qualifications

All Henderson County Solid Waste Disposal taxes are received by the Finance Department quarterly by the NC Department of Revenue. When these funds are received they are deposited directly into a Solid Waste revenue line item per NC GS 150-187.63. Henderson County Solid Waste operates as a true enterprise fund and no County taxes are used for Solid Waste expenditures. The Solid Waste Disposal tax funds are not tied to any particular Solid Waste expenditure.

Henderson County has recycling at all government buildings for patrons as well as employees. All employees have been given a small bin to place under their desk for recycling, and in some locations employees only have recycling in their offices, with trash receptacles placed in common areas. Henderson County office buildings, the gasoline and CNG pumps, and libraries (with the exception of one library) also have outdoor recycling receptacles at the main entrance for building visitors to recycle away from their homes. Common area recycling bins such as those in break rooms have posters to remind employees as to what items are recyclable and what items need to be placed in the trash.

## **Project Narrative**

Henderson County Solid Waste and Henderson County Parks and Recreation seek to improve the Henderson County Parks and Recreation Recycling Program. Henderson County plans to place 26 bins in the two largest Henderson County parks; with 20 bins being placed in Jackson Park, and six bins being placed in Etowah Park. This recycling program will improve the existing system of recycling in Henderson County parks for residents and visitors. The current recycling bins are very old and not designed to withstand the elements, many of the bins have floated away during heavy rainstorms and flooding events over the years. This program will also expand the number of bins placed in Henderson County parks.

The most recent statistics demonstrate that the Henderson County Recycling Program accepted 2687.11 tons of recycling in fiscal year 2012; 343.42 tons were collected from county buildings alone. In the first half of fiscal year 2013 Henderson County collected 438.45 tons of recycling at its new Convenience Center, 501.22 tons of recycling through the hauler recycling program, and 24.3 tons of recycling at Henderson County office buildings, including recycling from Henderson County Parks and Recreation. The expansion of recycling, by adding permanent bins to Henderson County's park facilities will comply with the North Carolina General Statues' ban on materials such as plastic bottles, wooden pallets, oil filters and aluminum cans from the waste stream (NC G.S. § 130A-309.10). By enhancing the recycling opportunities in Henderson County solid waste disposal costs will be cut and valuable materials will be reclaimed before entering a landfill.

Increasing the amount of recycling that we collect and send to American Recycling not only benefits Henderson County financially, it economically benefits our region by helping to sustain jobs that were created when American Recycling opened the second materials recovery facility in our region.

By adding recycling bins in Jackson and Etowah Parks Henderson County will be increasing public awareness for recycling in our region, as well as encouraging other counties and municipalities to establish recycling in their parks. Additionally, increasing the recycling rate in Henderson County helps to fulfill our goals established in the County's Ten Year Solid Waste Management Plan to establish a 40% solid waste reduction goal through improvements to recycling and other programs. An intermediate reduction goal of 25% is established for FY 2017 and a 30% goal by FY 2022.

Jackson Park is Henderson County's largest park established in 1974 with over 100,000 visitors per year. The park is host to youth soccer leagues in the spring and fall, year round tennis, youth baseball in the spring and fall, adult softball in the spring, summer and fall, bike races, running races, shelter rentals, bird watching, charity walks, Farm City Day, Henderson County Annual Easter Egg Hunt, car shows and high school athletics (tennis, cross country, women's softball).

Additionally, Jackson Park is the hub of the growing greenway system and has a playground for children.

Etowah Park became a Henderson County park in 1995, when 18 acres was turned over to the County from the Etowah Lions Club, who utilized funds from their garbage service to purchase land for a community park in the area. Etowah Park's facilities include a shelter, picnic tables, playground, a walking trail, tennis courts, baseball fields, a soccer field and shuffleboard court, with a Frisbee golf course planned.

All trash and recycling bins are checked daily by Parks and Recreation employees to see if they need to be emptied. When bins need to be emptied, the recycling is taking to the Parks and Recreation main office where it is picked up by our service provider, Consolidated Waste Services every Friday morning.

The bins will be labeled "Recycling" along the front and will have stickers/decals with the Henderson County Recycling logo on the sides of the dome lid. In downtown Hendersonville we have single stream recycling and have had very little contamination problems. We expect that the parks will be very similar.

The total capital expenditures for this project are estimated at **\$15,999.00.** Henderson County will also include matching funds of **\$3,199** towards the grant (see Budget and Quotes). This grant application requests a total of **\$12,800** toward the purchase of twenty six, 55 gallon permanent recycling bins, for Jackson and Etowah Parks in Henderson County, twenty bins will go to Jackson Park and six bins will go to Etowah Park.

## Milestones and General Implementation Dates

- November 30, 2013: Purchase, install and begin use of recycling bins.
- June 30, 2014: Final report submitted to NC DEAO.


