SUMMARY OF REQUEST:

Staff received the attached petition to add Sunoake Courtto the state road system. It has been the practice of this Board to accept road petitions and forward them to NC Department of Transportation for their review. It has also been the practice of the Board not to ask NCDOT to change the priority for roads on the paving priority list.

N.C. Gen. Stat. §136-62 provides that citizens may petition the State, through the Board of Commissioners, concerning additions to the State's road system, and concerning improvements to that system. "The board of county commissioners shall receive such petitions, forwarding them on to the Board of Transportation with their recommendations."

Staff reviewed attached petition and it appears that all affected property owners or developers have signed the required petitions.


BOARD ACTION REQUESTED:

I move that the Board direct staff to forward the petition to NCDOT, noting that the Board recommends approval.


State Road Petition Sunoake Court
