# RESOLUTION DECLARING PERSONAL PROPERTY AS SURPLUS AND AUTHORIZING THE SALE OF SURPLUS PROPERTY BY ELECTRONIC PUBLIC AUCTION

WHEREAS, Henderson County owns the Vehicles and Equipment itemized on the attached Exhibit B, hereinafter referred to as "surplus property", that is either obsolete or no longer needed for any governmental use by the County; and

WHEREAS, the Henderson County Board of Commissioners is desirous of declaring the Vehicles and Equipment as surplus and selling at a public auction as authorized by NCGS 160A-270; and

**WHEREAS**, it is the intent of the County to sell said surplus Vehicles and Equipment by electronic public auction at <u>www.govdeals.com</u> or <u>www.publicsurplus.com</u>.

**NOW THEREFORE BE IT RESOLVED,** by the Henderson County Board of Commissioners as follows:

- 1. The Vehicles and Equipment itemized on the attached Exhibit B is hereby declared to be surplus property.
- 2. The Purchasing Agent is hereby authorized to sell by electronic auction at <u>www.govdeals.com</u> or <u>publicsurplus.com</u> the surplus property described above to the highest bidder.
- 3. All surplus property will be sold "as is", all sales final, cash, certified check or money order only. Henderson County makes no express or implied warranties of merchantability of any surplus property, or part thereof, or its fitness for any particular purpose regardless of any oral statements that may be made concerning the surplus property or any part thereof.
- 4. A notice summarizing this Resolution and the sale of the surplus property by electronic public auction shall be advertised by the Purchasing Agent on the County's website at <u>www.hendersoncountync.org</u> at least ten (10) days prior to the public auction.
