SUMMARY OF REQUEST:

Engineering has developed a program that will divert roofing shingles from our waste stream at the Stoney Mountain Transfer Facility. The proposed program also reduces the cost of shingles disposal to roofing contractors and residents from the tipping fee of \$57/ ton to the proposed fee of \$35/ ton. A request for proposals was released to haul and recycle our shingles, and the successful bid is a significant reduction per ton from the waste hauling and disposal cost which will permit the reduced fee. The vendor will recycle the shingles collected at our Facility into asphalt production. An education and outreach program for county-wide contractors, roofers, and the general public is being developed by Environmental Programs and Solid Waste and will be presented through local industry-related organizations in 2014.

Henderson County will be the second county in the region to offer this service to residents and contractors through our Transfer Station facility.

Attention Shingle Haulers and Contractors!

A **Shingle Supplier Certification Form** is required for each load of shingles accepted for recycling.

Forms can be picked up at the landfill **Scale House** or found **online** at www.hendersoncountync.org/ engineering/solidwaste/feesindex.html

It is the **Haulers/Contractors Responsibility** to provide this required form to the attendants at the Henderson County Transfer Station Scale House.

List of information needed for the Shingle Supplier Certification Form:

- Company or facility name, supplier name, address, contact name, phone, verification the tear-off shingles are from a single family home or residential building having four or fewer dwelling units (per EPA NESHAP requirements).
- Provide the addresses where the tear-off shingles were removed.
- Sign and date

Get the Facts about Asphalt Shingle Recycling!

Did you know

Statewide it is estimated that there are more than 277,000 tons of shingles available annually for recycling.

Reasons to recycle shingles...

- Customers SAVE MONEY through reduced tipping fees.
- Asphalt shingles are recycled into usable paving material, thereby reducing the need to create new asphalt from new resources.
- Taxpayers save money through reduced road construction costs.



*Paperwork is required for each load of shingles brought to be recycled (see reverse side for form requirements).

*Loads must be tarped or covered and tied down to enter the Transfer Station facility.

Directions:

From Hwy. 25 (coming from downtown Hendersonville): turn left onto Stoney Mountain Road. Follow for 2.3 miles. Transfer Station will be on right.

From Hwy. 191 (Brevard Road; coming from downtown Hendersonville): turn right onto Mountain Road, take 1st right onto Stoney Mountain Road. Transfer Station will be on left.

Fees:

Only clean residential asphalt tear-off shingles are accepted at \$35.00 per ton. Shingles from large commercial/industrial buildings are NOT accepted for recycling. Contact Environmental Programs for assistance on appropriate disposal options, call (828) 694-6524.

Load Requirements for Shingle Recycling

What is accepted?

- Shingles
- Felt attached to shingles
- Roofing nails

What's not accepted?

- Asbestos-containing materials
- Built-up asphalt roofing
- Garbage or mixed trash
- Metal flashings, gutters, etc.
- Paper waste
- Plastic wrap, buckets, other rigid plastics
- Rolls or sheets of felt paper
- Shingles containing mastics
- Wood

Other bins are provided directly adjacent for non-asphalt—shingle waste. PLEASE help us keep the shingle loads free of non-acceptable waste!
