Staff posted signs in the affected area regarding the public hearing and advertised the public hearing in a local newspaper.


BOARD ACTION REQUESTED:

I move the Board (approve/deny/approve with modifications) the road name of Barbara Ann Lane as indicated on the attached map.


Re-Naming of Yorkshire Boulevard
