SUMMARY OF REQUEST:

At the 2014/2015 Budget Meetings of the Fire and Rescue Advisory Committee, Etowah-Horse Shoe Volunteer Fire & Rescue Department presented a proposal to purchase a new Ladder Truck and consolidate other outstanding loans. The total amount financed will be \$1,333,231.26 at a fixed interest rate of 2.43% with annual payments of \$286,395.82 for 5 years. Etowah-Horse Shoe Volunteer Fire & Rescue Department held a public hearing to discuss the loan agreement on August 15, 2014 at 7:00 p.m. at their department. No tax rate increase will be necessary for this purchase.

The Fire & Rescue Advisory Committee has unanimously recommended approval of the proposal.

I am Chairman of the County Commissioners of Henderson County. This letter is to advise you that: Etowah-Horse Shoe Volunteer Fire & Rescue Department, Inc. is a qualified Volunteer Fire Department, assigned to protect a specific Fire District within this County.

In addition, a special ad valorem (fire tax) is assessed on the real property owners of this district. Said tax is to be used exclusively to provide equipment, facilities, and training as is necessary to provide fire protection for said district. Said funds may also be used to upgrade equipment as the need arises. This tax is collected by the County and disbursed by the Finance Office to the Fire Department on a regular basis by the County Finance Officer. The Fire Department is operated and managed by the Board of Directors of the Fire Department and the Officers of said Department. The Department is currently meeting the requirements of their fire service contract.

The Fire Department has made us aware of their intention to acquire new capital assets through a Lease Purchase transaction with your firm. Please be advised that the County has no objection to this transaction.
