Thank you for your willingness to serve in this capacity. I am grateful for citizens like you who give their time and talent to serve the State of North Carolina.

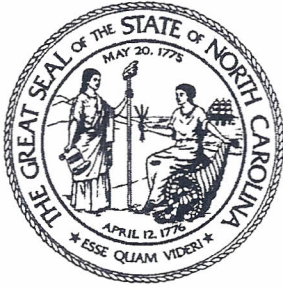

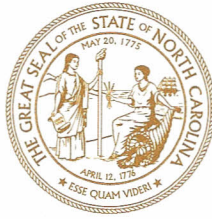
