SUMMARY:

A public hearing has been scheduled on 5 October 2015 in the above matter.

As noticed to the public, the public benefit to be derived from the proposed capital project is a total taxable capital investment by BorgWarner Thermal Systems, Inc. of at least \$8,200,000.00 in business personal property (equipment). The project would result in the creation of at least thirty-one (31) new jobs, at an average wage in excess of the average wage in Henderson County for full-time employment, plus other benefits. The contemplated incentives would last for a period of seven (7) years. The first year's contemplated incentive, if granted, would be not more than \$29,481.00. The maximum amount of incentives to be considered in this grant over the seven years would be \$140,033.00.
