SUMMARY OF REQUEST:

Construction Contract: As directed in the Board's approved budget, The Old Fairgrounds Site Development project was bid on March 10, 2015. As recommended by WGLA Engineering on the attached letter, JLS Construction is presented to the Board for award of the construction contract. (The proposed contract is for \$412,285.00. The bid tabulation is attached as well.

The proposed budget is as follows is also included in the letter of recommendation from WGLA with the total project budget of \$450,000.00

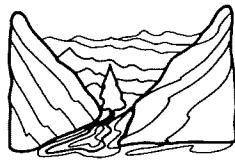
The approval memo from ARC for the additional \$100,000 was received on October 16, 2015 and is attached.

Summary of Bid Results

Dear Mr. Jones

On Tuesday, March 10, 2015, we received bids for the rough grading of the Old Fairgrounds property. The bids ranged from a low of \$263,277.00 submitted by Thunder Disaster Recovery to a high bid of \$525,702.50 submitted by Tennoca Construction. A total of 8 bids were received.

The bid submitted by Thunder Disaster was significantly less than the second lowest bid of \$412,285.00 submitted by JLS Construction. I contacted Thunder Disaster Recovery, and they indicated they made a mistake in preparing their bid. They subsequently submitted a letter formally requesting that their bid be withdrawn from consideration due to their error. As a result the apparently low bidder is JLS Construction at a total of \$412,285.00.

I believe the bids received were reasonable and a fair cost to complete the project. The original estimate did not take into account additional material that had been placed on the site from the second Elkamet expansion. Also, the bid included approximately \$90,000.00 for stabilization of the site as recommended by the geotechnical engineers.

All of the bids exceeded the budget available for construction of \$223,000.00. As you know, this project is funded by a grant of \$175,000.00 from ARC with a match from Henderson County of \$75,000.00. To proceed with construction and provide a reasonable contingency, I would estimate that an additional \$210,000.00 is needed.

At this time, the Henderson County Partnership for Economic Development has committed \$50,000.00 to this project, and that has been matched by Henderson County. Also, I understand that ARC has committed an additional \$100,000 to the project to match this increase in local funding. Based on this additional funding, we would recommend the following project budget moving forward:

I have spoken with JLS Company, and they are comfortable holding their bid pricing knowing the project will be moving forward. They may request some flexibility on a start date depending on their workload at the time a notice to proceed can be issued.

Description:

The county requests additional funds in the amount of \$100,000 due to the increased cost of construction following receipt of the bids. The scope of the original project has not changed significantly. However, during the on-site assessment the project engineers discovered two site-specific considerations that will slightly expand the project scope and thereby increase costs as well. The site considerations include: 1) geo-grid stabilization is needed for one portion of the project site, and 2) excess soil was deposited on the site from a grading project on the adjacent parcel. The county's original contribution of \$75,000 will increase by \$50,000 to a total of \$125,000 and the Henderson County Partnership for Economic Development will contribute \$50,000 to cover a portion of the cost overruns. The project will allow Henderson County to complete site development and rough grading improvements for a 17.2 acre tract to make the property marketable as an industrial site. The grading effort will result in two distinct building pads. Henderson County owns the property, located in East Flat Rock, an unincorporated, economically distressed area of Henderson County. All necessary utilities are available at the site and it is located in close proximity to Interstate 26, the Asheville Regional Airport, and rail infrastructure.

Rationale/Benefits:

As noted in the project's original approval memo, the grading effort will reduce the time that a prospective client would need to begin construction. The site has capacity to support one to two new businesses and create up to 100 new jobs. The Henderson County Partnership for Economic Development and other regional economic development partners are actively marketing the site as an ideal industrial property with multiple transportation access systems and full utility connections. The region has recently attracted national corporations to locate east-coast facilities nearby, due in part to the area's natural environment and quality of life. However, the mountainous terrain and associated infrastructure construction costs are barriers to locate, secure, and develop viable industrial sites in western NC. After site development and grading, private sources will contribute to further development of the site. The property could be fully occupied within one year following the completion of the proposed improvements.

The project will also support the county's efforts to remove the property from the NC Department of Environment and National Resources (NCDENR) Inactive Hazardous Waste Site Priority List. The property was previously used as a fire prevention training site. As a result the site improvements, the county will re-purpose an abandoned site into a revenue-producing property.

Performance Measure (Outputs):

Expected outputs have not changed; 17.2 acres will be graded to become 'pad-ready.'

Performance Measure (Outcomes):

Expected outcomes have not changed. As a speculative building site there are no formal job creation commitments, however, estimated outcomes include 102 jobs created.

This project will have a primary impact on distressed areas. The project is consistent with the ARC Act and Code and is recommended for funding.
