**SUBJECT:** Conduct three (3) public hearings for assignment of new road names

#### SUMMARY OF REQUEST:

North Carolina General Statute 153A-239.1 requires the Board to hold a public hearing prior to assigning a new road name. On October 5, 2015 the Board set three public hearings to consider the naming of three roads (Access Lane, Stay A Way, Peaceful Meadows Lane). The road name assignment is required by the Henderson County Property Addressing Ordinance (Chapter 41) and will avoid possible confusion when responding to emergency situations.

Staff has received consent from 100% of the affected property owners meeting our ordinance requirement. Staff posted signs in the affected area regarding the public hearing and advertised the public hearing in a local newspaper.

#### BOARD ACTION REQUESTED:

The Board must hold three hearings to consider the proposed road name changes. A suggested motion to approve each road name assignment has been provided below.

#### Suggested Motion:

I move the Board approve the road name assignments as indicated on the attached maps for the following roads;  
Access Lane,  
Stay A Way, and  
Peaceful Meadows Lane.

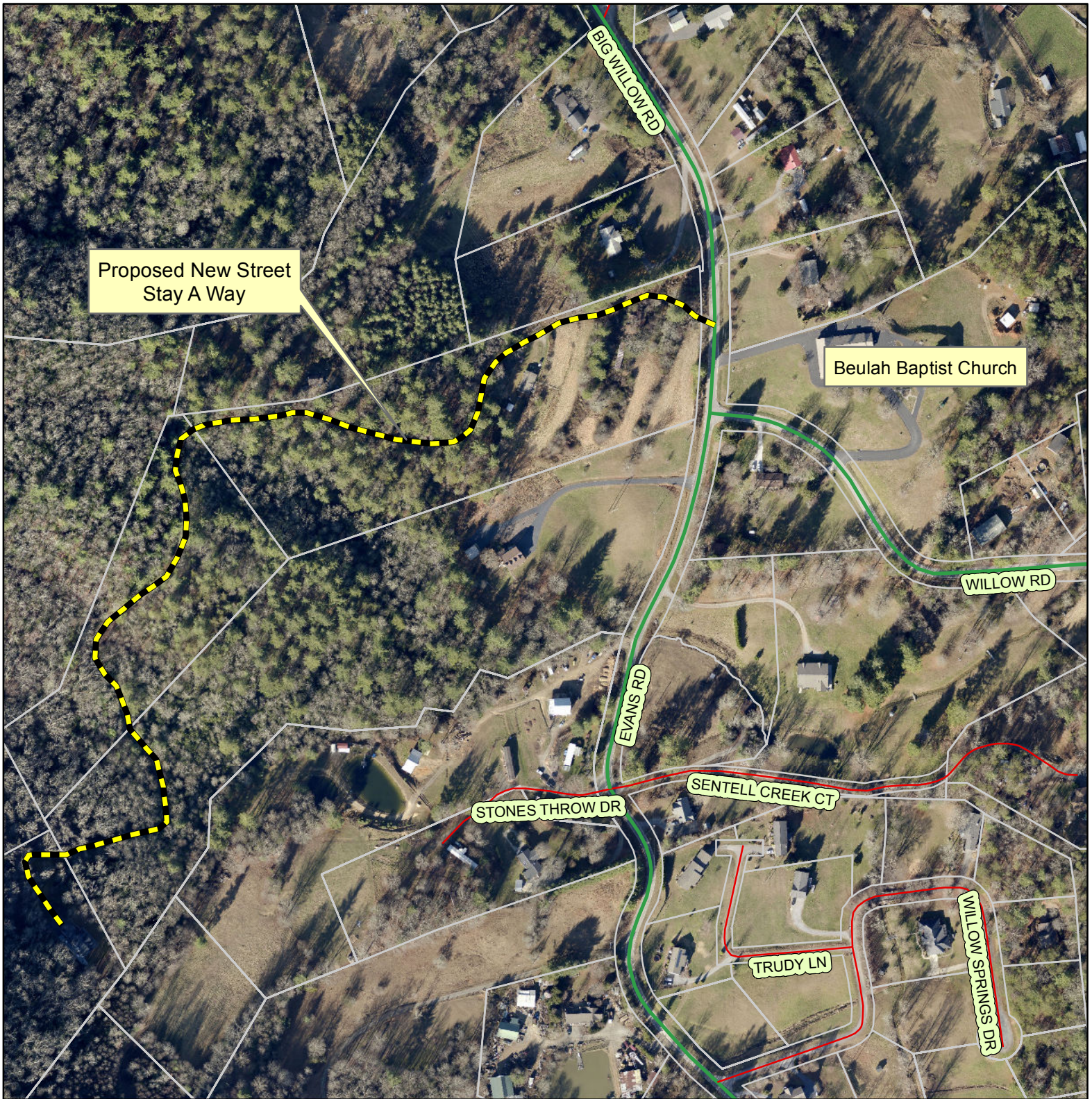
