AWARD CONSTRUCTION CONTRACT - MILL POND CREEK PROJECT

**Construction Contract:**

Marcus Jones stated as directed in the District's approved budget, Mill Pond Creek Project was bid on May 28, 2015. As recommended by WGLA Engineering via letter, Buchanan and Sons, Incorporated is presented to the Board for award of the construction contract. The proposed contract is for \$2,219,311.50. Mr. Will Buie of WGLA Engineering, PLLC, was present for questions.

The project falls within the statutory requirements for a formal bid process and therefore, the Engineer has conducted the bidding accordingly. Additionally, the project was advertised in the local newspaper and posted on the County website.

The proposed budget is as follows:

This project will use CCWSD enterprise funds. No General Fund or tax dollars will be used.

*Commissioner Lapsley made the motion that the Board of Directors award the construction contract for the Mill Pond Creek Project to Buchanan and Sons, Incorporated for \$2,219,311.50, approve the proposed project budget of \$2.5m, and authorizing the County Engineer to execute the required documents. The motion passed 4-0.*

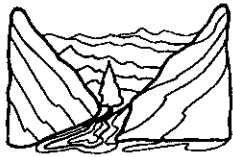

Dear Mr. Jones:

Bids were received for the Millpond Creek Pump Station and Sewer Extension on Thursday, May 28, 2015. Four bids were received ranging from a low bid of \$1,964,048.00 submitted by Steppe Construction to a high of \$3,730,470 submitted by Hall Contracting Corporation. Our estimate for this project was \$1,851,675.00; however this estimate was not adjusted after the sewer line had to be redesigned to avoid several property owners who were unwilling to grant easements.

Unfortunately, we received a letter from Steppe Construction requesting that they be allowed to withdraw their bid due to mathematical errors. Their bid was approximately \$640,000 lower than then next bidder. A copy of their letter is attached. Based on our review of the bids and the request received, we recommend that Steppe Construction be allowed to withdraw their bid.

Following Steppe's request to withdraw their bid, the second lowest bidder, Buchanan and Sons, requested a meeting to discuss possible value engineering options to consider for this project. Since Buchanan and Sons was the lowest responsible bidder at that point, we met with this several weeks ago to discuss the project. As a result of that meeting, they presented a number of possible value engineering options that could reduce the construction contract to \$2,196,311.50.

After reviewing these value engineering items with the Cane Creek staff, we believe it is reasonable to accept a number of the options which would reduce the proposed construction contract to \$2,219,311.50. The County could move forward with a contract on this project or they could reject all the bids and rebid the project this fall. There are certainly no guarantees that rebidding the project would result in a lower construction contract. This would likely be dependant on the bidding environment at that time.

Should you chose to proceed with the project, we would recommend the following budget:
