#### **SUMMARY OF REQUEST:**

The County has received a request from Sierra Nevada Brewing Co. (SNBCo) for the use of the 1995 Courthouse north parking lot, off of 4<sup>th</sup> Ave, see attached letter. This request is associated with SNBCo's Oktoberfest Celebration. SNBCo proposes to utilize the parking lot as "a central and safe location for residents to load/un-load" their shuttle bus.
