SUMMARY OF REQUEST:


The Boards of Directors and Chiefs of Edneyville Fire & Rescue and Dana Fire & Rescue have mutually agreed to transfer the fire districts of certain parcels to facilitate a more efficient and timely response to those citizens. A public meeting was held for citizen's comments on August 2, 2016, at 6:00 p.m. at North Henderson High School cafeteria after announcements were run in the Hendersonville Lightning on July 20 and July 27, 2016. Information about the proposed changes was also posted at 5 locations in the affected areas. No members from the public attended the meeting, and the meeting was adjourned at 6:30 pm. A letter of explanation was later sent to each affected property owner.

The Board is requested to approve the amended fire tax districts as shown on the enclosed map, and authorize the Chairman to sign the proposed letter requesting Representative Chuck McGrady introduce a local bill authorizing approval of the new Fire Tax District maps.

Re: Amendments to Edneyville and Dana Fire Tax Districts.

Representative McGrady:

This letter is to request introduction of a Local Bill in the North Carolina House of Representatives to approve transfer of parcels between Edneyville and Dana fire tax districts in order to serve the owners of those respective properties more efficiently. The ISO protection ratings of the departments are 5 and 4 respectively, which would mean insurance rates on residential properties would not change due to the transfer. However, there is a 2.5 cent difference in fire taxes levied, meaning those parcels transferred to Dana fire district would experience an increase in fire taxes, while those transferred to Edneyville would see a decrease. Citizens were advised, and no one attended properly advertised public meetings.

The enclosed map shows the extent of the amendments and which parcels would be affected.

Please be advised that the County has no objection to this transaction.

Dana and Edneyville Fire Department's are hoping to move existing district lines to help improve response to citizens within certain areas. Both departments have gotten together and looked at district lines that just don't make sense the way they are now. With Edneyville currently traveling up to 5 miles to reach an area that Dana can get to within a mile of their station and with Dana traveling up to 5 miles to an area that Edneyville can reach within 2.5 miles of their station. Both Chief Womack of Dana FD and Chief Griffin of Edneyville felt that it is time to change where the lines were drawn. Both chiefs as, well as the board of directors at both departments, are hoping to move district lines to help lower response times for people in the affected areas on an average of 4 minutes.

The areas that would be affected include the Ridge Rd area up to and including parts of Sugarloaf Rd, Chestnut Stump Rd area that would go from Edneyville Fire dept to Dana Fire Dept. Areas that would go from Dana Fire Dept to Edneyville Fire Department include Chimney Rock Rd from Fruitland Rd to Chestnut Gap and Fruitland Rd from Chimney Rock Rd to Simms Alley. An informational meeting will be planned for August 2 at 6pm at North Henderson High School.
