#### **SUMMARY OF REQUEST:**

The County has received a request from Sierra Nevada Brewing Co. (SNBCo) for the use of the 1995 Courthouse north parking lot, off of 4<sup>th</sup> Ave. The request letter is attached. This request is associated with SNBCo's 2017 Oktoberfest Event on September 30 from 5:00 pm to 10:00 pm.

SNBCo proposes to utilize the parking lot as "a central and safe location for residents to load/un-load" the SNBCo shuttle bus. The shuttle bus is complementary and will run between Hendersonville and the brewery during the event to provide "safe transportation."
