SUMMARY OF REQUEST:

The City of Hendersonville has requested that the County comment on a proposed water and sewer line extension to thirty-three proposed single-family homes in Phase 4 and 5 of Dodd Meadows Habitat for Humanity Subdivision located off E. Blue Ridge Road along Volunteer Way. The proposed water line is 750 linear feet in Phase 4 and 880 linear feet in Phase 4. The proposed gravity sewer line is 527 linear feet in Phase 4 and 710 linear feet in Phase 5. The project's location within the Urban Services Area is consistent with the Henderson County 2020 Comprehensive Plan. A City of Hendersonville project summary sheet is attached for Board review and action. This expansion will be funded by Henderson County Habitat for Humanity.


BOARD ACTION REQUESTED:
