#### **SUMMARY OF REQUEST:**

At the May 16, 2017 Meeting of the Fire and Rescue Advisory Committee, Mills River Fire & Rescue presented a proposal to purchase a new Engine/ Pumper as part of their FY 17-18 budget. The total amount financed will be \$571,000 at a fixed interest rate of 2.45% for 7 years. Mills River Fire & Rescue held a public hearing to discuss the loan agreement on July 10, 2017 at 7:00 p.m. at their department.

As part of the budget process the Fire & Rescue Advisory Committee has unanimously approved the purchase of the truck.
