SUMMARY OF REQUEST:

Teresa Galloway has applied, on behalf of herself and Robert Dennis Lewis, Jr., pursuant to §20-5 of the Henderson County Code, for a license to conduct the business of pawnbroker within Henderson County, at 5360 Hendersonville Road, Suite 129, Fletcher, NC 28732. This is the first application for a license at this location. She has supplied the attached documentation for such license, including the \$50.00 annual fee.

Under your ordinance, there is an annual renewal of this license by staff, if granted by the Board. §20-6 requires that such applications be brought “for consideration by the Board of Commissioners at a regular scheduled meeting”.

Neither I nor any other owner of this business (if any) or any prospective employee has been convicted of any felony.

I have attached the following information, which is all true to the best of my knowledge, information and belief:

- Criminal record check for applicant and all owners of business.
- License and permit bond.
- Financial statement indicating the amount of net assets or capital proposed to be used by the petitioner in operation of the business, verified by an accountant or certified public account (need not be audited).
- A criminal record check from the Clerk of Court of every county where the applicant has resided during the past ten years.
- References from two or more local citizens to demonstrate good character.
- A list of all pawnshop owners (including owners of shares of any corporation, or limited liability company) and employees.
- A Henderson County criminal record check for all prospective pawnshop employees (attach list and update as necessary).
- A certificate from the Sheriff of Henderson County or the State Bureau of Investigation that the petitioner and no owner of the business has been convicted of a felony.
