The Henderson County Board of Commissioners met for a regularly scheduled meeting at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

CALL TO ORDER/WELCOME

Chairman Edney called the meeting to order and welcomed all in attendance.

Chairman Edney made the motion for the Board to convene as Cane Creek Water & Sewer District Board. All voted in favor and the motion carried.

Staff request approval of minutes from a previous meeting of the Cane Creek Water & Sewer District.

1) June 5, 2017

Commissioner Hawkins made the motion to approve the Cane Creek Water & Sewer District minutes of June 5, 2017. All voted in favor and the motion carried.

Award Construction Contract - Norafin Sewer Extension

Construction Contract: Marcus Jones stated as directed in the District's approved budget and the approved NC Rural Infrastructure grant, Norafin's sewer extension was bid on October 12, 2017. As recommended by WGLA Engineering on the attached letter, Steppe Construction is presented to the Board for award of the construction contract. The proposed contract is for \$170,761.

The recommended contract amount reflects additional linear footage of gravity line beyond the bid quantity. The bids were favorable and allow the line to be extended to a future phase of Norafin's plant and still stay under the approved grant budget for construction of \$177,700.

Per grant requirements the project was bid under formal construction statutes and therefore, the Engineer bid the project accordingly. Additionally, the project was advertised in the local newspaper and posted on the County website.

The proposed construction budget is as follows:

Construction Contract Project Contingency

\$170,761.25 \$24,938.75

This project was approved in the FY2018 budget, and by the NC Rural Infrastructure grant for \$207,575. At the time this agenda item was published, we have not formal grant approval for the additional footage; however, we expect approval by the Board's meeting.

Commissioner Thompson made the motion that the Board of Directors award the construction contract for the Norafin sewer extension to Steppe Construction for \$170,761.25, approve the proposed project budget and authorize the County Engineer to execute the required documents. All voted in favor and the motion carried.

Chairman Edney made the motion to adjourn as the Cane Creek Water & Sewer District Board and reconvene as the Board of Commissioners. All voted in favor and the motion carried.

Dear Mr. Jones:

Bids for the Norafin sewer extension we received by the County on Thursday, October 12, 2017 at the Henderson County offices at 100 North King Street. Bids ranged from a low of \$108,405.00 submitted by Steppe Construction to a high of \$165,815.00 submitted by Hyatt Pipeline. A copy of the bid tabulation is attached with this letter.

As you will recall, this project is being funded with a grant from the NC Rural Infrastructure Authority. The funds available for construction through the grant total \$177,700.00. We have discussed extending the proposed sewer line to provide service to the western portion of the property. I have attached a sketch showing the possible extension along with an estimate for the extension based on the low bidder's unit prices. The low bidder has agreed to extend the sewer using their unit prices. Therefore, the construction cost for the extension would be \$170,761.25. This includes the base bid extension to Norafin of \$108,405.00 and the further extension on the property of \$65,356.25.

We would recommend the following project budget going forward with construction:

Construction Contract

\$170,761.25

Project Contingency

\$ 24,938.75

This construction budget corresponds with the budget presented to the NC Rural Infrastructure Authority.


