SUMMARY OF REQUEST:

The Federal Partnership for Sustainable Communities awarded Land of Sky Regional Council (LOSRC) a major grant to participate in a new planning project for our 5-county region (Buncombe, Haywood, Henderson, Madison, and Transylvania counties). The effort contains a multi-disciplinary approach covering subject areas including: economic prosperity, quality growth, and sustainable development. Specific analysis for the region and each county will include economic issues, housing, transportation, natural & cultural resources, energy & land use.

This initiative intends to avoid duplication of previous planning efforts by building upon existing municipal & county plans such as Henderson County's 2020 Comprehensive Plan. A steering committee consisting of 13 persons, with one person appointed by each county, will guide the results. The Henderson County Board of Commissioners (BOC) approved participation in the process at their meeting on September 6, 2011. The BOC will appoint Henderson County's representative in the coming weeks.

There is no financial obligation for Henderson County to participate in the process. It is expected that participants in this process will gain preferred status for federal grant applications. Henderson County staff anticipates using the detailed research and data from this project, created for each county, to create and update local plans and strategies that enhance our quality of life, e.g. Comprehensive Plan, Strategic Plan, etc. Participation in the process does not obligate any local government to the results of the initiative (WNC Livable Communities Plan).

Linda Giltz, AICP, a senior planner with Land of Sky Regional Council, will present the information and will answer questions of the board.

BOARD ACTION REQUESTED:

The Board is requested to consider the presentation, discuss the project, and ask any questions relating to the effort. The Planning Board will play a significant role in this process.


Livable Communities Initiative

WHAT IT IS: The Initiative is a 3-year project to develop a regional vision for economic prosperity, quality growth, and sustainable development. A consortium of local governments, residents, and organizations in Buncombe, Haywood, Henderson, Transylvania, and Madison Counties will draw on existing plans and strategies to develop a plan to foster economic prosperity through a regional vision that identifies implementable projects and actions. The project will include significant public outreach and involvement. The Initiative is not about starting from scratch. It will draw on significant work that has already been accomplished in the region, weaving together existing plans with public involvement. The Initiative is not a central authority over the region's local governments, but is instead a way for the region to identify common goals and objectives that can be attained by working together.

WHY: Citizens and leaders in Western North Carolina have identified "greater regional coordination" related to economic development, quality growth, and sustainability as a primary need for the region. The project will allow local governments, businesses, non-profits, citizens, and others to realize unprecedented regional coordination on jobs, energy, housing, transportation, resources, and other interconnected issues. This will foster more prosperous, livable communities in our region through new quality jobs, new investment, diverse economic development strategies, energy and financial savings, and carbon emission reductions.

HOW: During the three-year project, the Consortium will work together to gather public input and weave together existing plans and strategies across topic areas in the **Local Livability Framework** (see below). Their work is funded by a grant from the Department of Housing and Urban Development (HUD), through the Sustainable Communities Initiative.






Project Goals

- · Seek implementation opportunities throughout the process
































Current Status

- A Request for Proposals was issued seeking assistance with implementation of the Initiative – responses were due July 15. Interviewed four teams in August and consultant team now under contract.
- · Early administrative requirements from HUD have been met
- Analysis of Impediments to Fair Housing underway
- RENCI mapping and data collection underway
- Preferred Sustainability Status
- Organizations, local governments, and others are signing the Consortium Agreement
- Beginning to develop outreach and communication strategy and
