The **HENDERSON COUNTY BOARD OF ADJUSTMENT** having held a quasi-judicial public hearing on July 25, 2012 to consider the application submitted by **Boyd Hyder** and the Variance request on August 29, 2012 have thus amended the July 25<sup>th</sup> Special Use Permit as follows:

#### FINDINGS OF FACT

- 1. A Special Use Permit was approved by this Board on July 25, 2012 and was vested to the site plan presented at the time of application.
- 2. A quasi-judicial public hearing was held by the Henderson County Board of Adjustment on variance request on August 29, 2012. The variance request was approved thus modifying the site plan.
- 3. A new site plan was submitted with the variance request dated July 23, 1012.

#### **CONCLUSIONS**

- 1. All parties, and all persons entitled to notice, have been given proper notice of this hearing and afforded the right to be heard.
- 2. All parties were properly sworn in before the Board of Adjustment and all evidence presented herein was under oath, and was not objected to by any party. All evidence relied upon in this Order was credible and reliable.
- 3. Henderson County Code 200A-323 grants the Board of Adjustment the jurisdiction to hear and make special use permit decisions and amend these orders.
- 4. The approved variance request modifies the site plan and thus the Special Use Permit must be amended.

Based on the foregoing FINDINGS OF FACT and CONCLUSIONS drawn, the HENDERSON COUNTY BOARD OF ADJUSTMENT deems the Special Use Permit to be **GRANTED**.
