BID OPENING
 JULY 3, 1990

The bid opening for the Henderson County Courthouse Dome & Roof Renovations was held at 3:00 p.m. on July 3, 1990, in Room # 208 of the County Office Building.

Those present were: Chairman William T. Drake, Stuart Stepp and Emory Jackson of Emory Jackson & Associates, Jamie Zeuner of Stroup Sheet Metal, Jim Crafton of Bildon Inc., and Clerk to the Board Elizabeth W. Corn.

Chairman Drake called the meeting to order and declared time for receiving bids closed as of 3:00 p.m. This is the second bid opening for this project, the first was on June 18 with an insufficient number of bids received to open.

Chairman Drake then directed Mr. Stepp to being opening the bids. Stuart Stepp opened the bids and Emory Jackson read them aloud.

General bids were opened first as follows:

Bildon, Inc. bid bond in order, base bid \$216,873, option bid \$1,432, time 120 days.

Dunlap Construction bid bond in order, base bid \$180,320, option bid \$400, time 180 days.

Roofing bids were opened next as follows:

Driscoll bid bond in order, base bid \$91,300, Alt. R1 bid \$10,500, Alt. R2 bid \$1,600, time 90 days.

Stroup bid bond in order, base bid \$77,149, Alt. R1 bid \$1,789, Alt. R2 bid \$863, time not given.

United bid bond in order, base bid \$104,351, Alt. R1 bid \$14,237, Alt. R2 bid \$2,330, time 120 days.


Emory Jackson said that this completes the bidding today. A list of bidders is attached.
