

## **A Resolution for Single Payer Healthcare for All**

**WHEREAS**, The United States is the only industrialized democracy that does not guarantee health care to all its citizens; and

**WHEREAS**, Our healthcare is the most expensive in the world with costs per capita more than twice any other country; with health insurance premiums increasing by 213% since 1999, and with 35% of every healthcare dollar consumed by administrative costs; and

**WHEREAS**, The current healthcare system weighs most heavily on the least advantaged—children, the working poor, and minorities—leaving thousands to die and hundreds of thousands more to face uncertain futures from major illnesses or financial ruin, that the system “rations” healthcare to those who can pay; and

**WHEREAS**, 62% of all personal bankruptcies are due to medical expenses; and

**WHEREAS**, American businesses, dealing with escalating healthcare costs, either cut medical insurance for employees or move production overseas because they are not competitive with foreign businesses in countries with universal healthcare; and

**WHEREAS**, The Affordable Care Act [ACA], Medicare, and Medicaid, face uncertain funding futures as a result of recent tax “reform” legislation passed in Congress; and

**WHEREAS**, The money saved by a single-payer plan would more than pay for extending coverage to those currently uninsured or underinsured; and

**WHEREAS**, Legislation has been introduced in both houses of Congress: H.R. 676 and S. 1804, which creates a “pathway to single payer,” and several states are independently pursuing single-payer legislation; now therefore,

**BE IT RESOLVED**, That the Henderson County Board of Commissioners do what is economically sustainable and beneficial for all, and adopt the Resolution for single-payer Healthcare for All.



I feel that we have an opportunity to address some of the problems we now have as well as in the future for the Edneyville Community. A problem facing the community is the lack of sewer service from North Henderson High School to the Justice Center. Sewer service along the Hwy 64E corridor would serve AG tourism, residential, business and school needs.

We need to consider what makes this area so special while protecting orchards, vineyards and farmlands, places that make our area a beautiful and a unique travel destination.

I believe the Barnwell Option would be the best. This option follows the 2010 small area plan that the Edneyville people developed. Which was presented to and approved by the commissioners. This option compared to the gravity system is less expensive.

This plan calls for the sewer line to follow Hwy 64E from the North Henderson High School to the Justice Center. This would keep the development along the main business corridor and close to that area. It would allow AG tourism business to expand and accommodate their customer needs by providing adequate restroom facilities.

The Barnwell Option could pickup several package sewer plants and businesses. This would clean up our streams now and in the future. Plus offering expanded opportunities to existing business such as restaurants, local stores, residential communities and private home owners.

Good morning commissioners. Thank you for the opportunity to address the board concerning the sewer line to the Edneyville school and community.

It will be wise to create a comprehensive system that will serve the foreseeable needs of the community now and also protect the future development opportunities that will surely come. ## The Edneyville Elementary School Sewer Service

The Edneyville Community would like to thank the Henderson County Commissioners for building the much needed new Edneyville Elementary School.

The Henderson County 2020 Comprehensive Plan identified several critical areas in the sewer component of the plan and the number three priority was public schools operating without sewer service. With the just completed line to Atkinson Elementary School only Edneyville Elementary School is now not served by a sewer line.

The community would like the Commissioners to follow the 2020 Plan and provide sewer service to the Edneyville Elementary School. Providing this service with the Barnwell Option will fit the Edneyville small area plan very well. A sewer line along highway 64 where the water line currently runs would serve the existing businesses, the Agritourism locations and planned future developments.

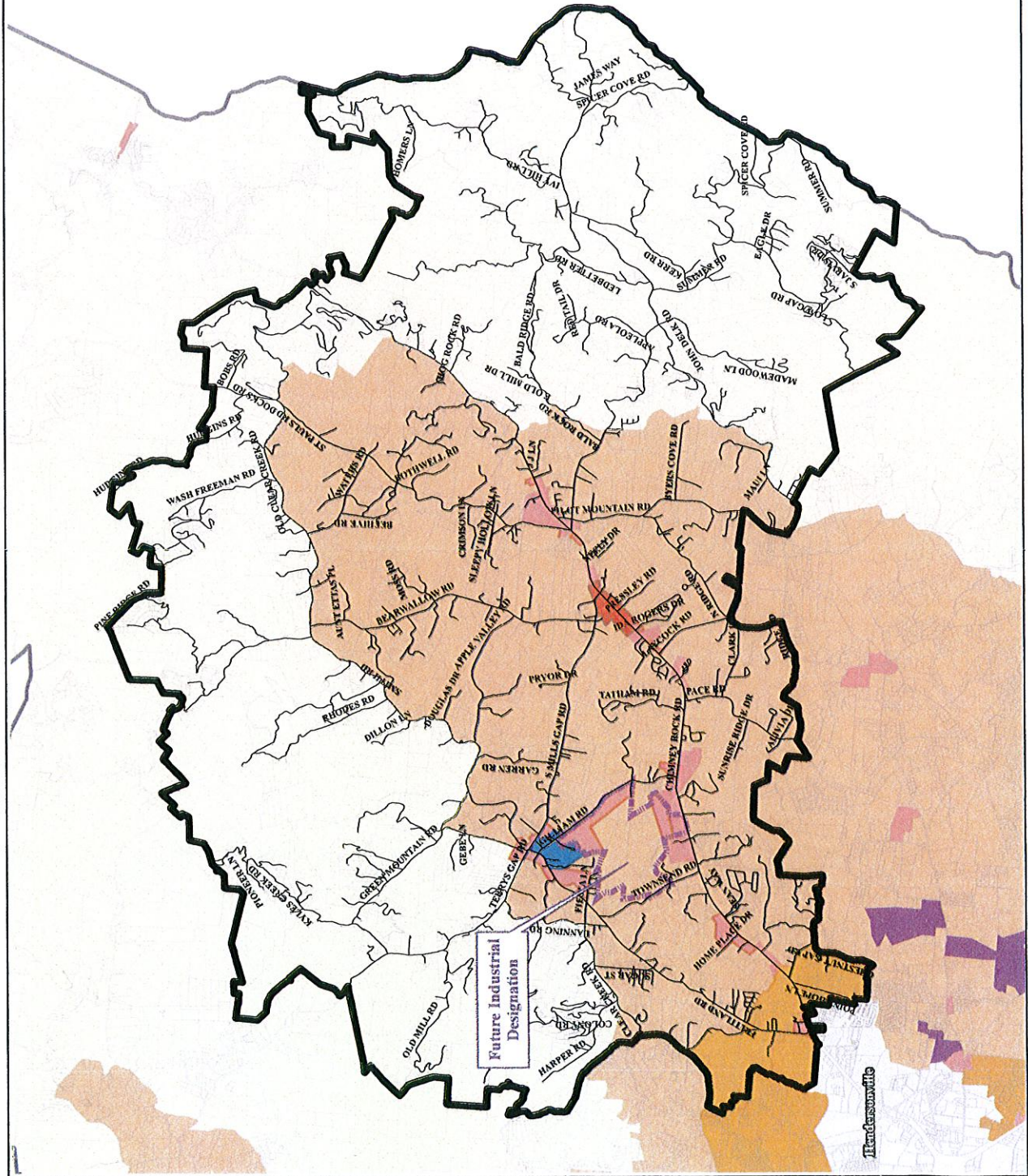

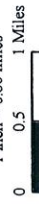

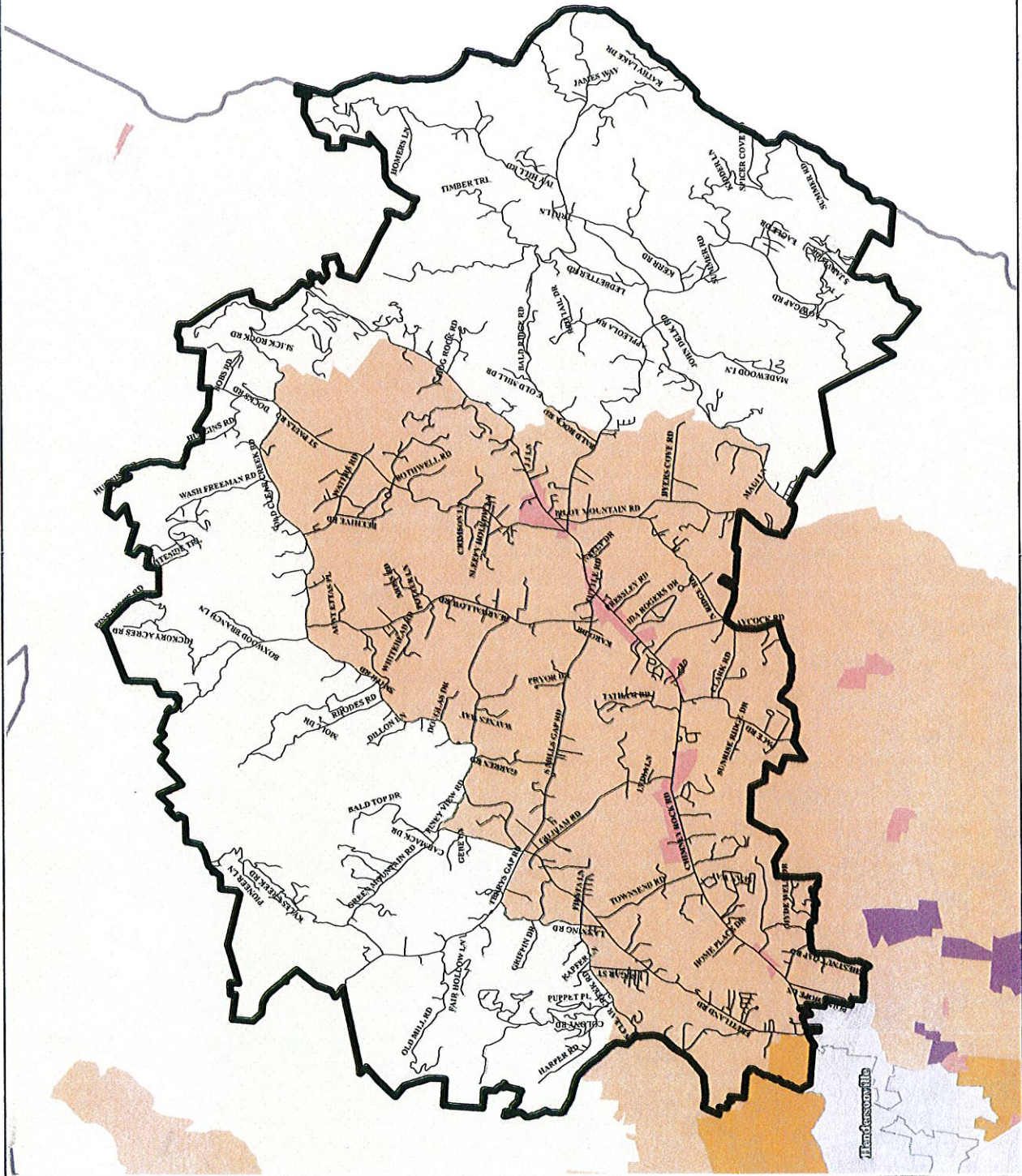

Local Businesses and Residents

Henderson County Commissioners,

RE: The STIP PROJECT NOS. U-5886 and U-6049 Roundabouts on White Street / Kanuga or Hebron Road / Kanuga Road.

We the business owners and residents of White Street, Kanuga and Hebron Roads oppose this project.

This Petition was signed in one week by 505 persons who live, work and/or patronize these local businesses. More signatures are being collected on a daily basis.

Many of these businesses have been in operation for over 20 years and are well established and patronized by area residents in the city and surrounding communities. Moving or closing of these businesses would be detrimental to area residents who frequent them and business owners, workers and their families who depend on their financial income.

We, as a community, are against the use of a roundabout(s) and the widening of White Street or Hebron Road. We cite the following reasons:

1. The use of a roundabout is generally considered difficult or confusing and requires "a learning curve" to navigate. Putting one in an area that is primarily a retirement population with heavy seasonal tourist traffic is a great concern for safety.  
We have large buses bringing tourists to Kanuga Conference, children's camps and area attractions. These drivers, not being familiar with this area or a roundabout will be at risk.
2. The footprint of a roundabout takes up considerable more property than a traditional stoplight configuration, therefore losing more businesses and personal property could be saved by a different configuration.
3. The widening of White Street would take out about 90% of all businesses currently there.
4. Small businesses are vital to preserving our small town character. To push out small businesses in favor of large stores takes away from our small town appeal and the reason so many people love to visit and live here.
5. A bike lane on White Street or Hebron would be hazardous on either road. Placed between two major roads (Kanuga and 225), this would lead a biker to either of two main roads with no other bike lanes to connect to.

We ask that this project be stopped until such time as it can be revised and reprioritized to a low impact plan to save and preserve the established businesses and residences. At this time we feel the alternative intersections (turn lanes) would be a more acceptable solution with regard to removing the bike lane, not widening White Street but adding two right turning lanes (from the bridge to 225) to the end of White Street and 225. One lane going into Publix and one to turn onto 225. This would solve any traffic issues without taking any small businesses or residences.

We are open and receptive to other alternatives and options with respect for our properties. We look forward to open communication and dialog with our city, county and DOT.
