#### CALL TO ORDER/WELCOME

Chairman Edney called the meeting to order and welcomed all in attendance.

Commissioner Hawkins made the motion for the Board to convene as Cane Creek Water & Sewer District Board. All voted in favor and the motion carried.

## Cane Creek Water and Sewer District - Minutes of July 18, 2018

Staff request approval of minutes from a previous meeting of the Cane Creek Water & Sewer District.

1) July 18, 2018

Commissioner Thompson made the motion to approve the Cane Creek Water & Sewer District minutes of July 18, 2018. All voted in favor and the motion carried.

# Award Construction Contract - Mud Creek Interceptor Project

Marcus Jones stated during the District's July 18, 2018, the Director's did not move to award the construction contract for the Mud Creek Interceptor project. Prior to awarding, the Directors instructed staff to continue securing the required utility easements and secure an additional easement over the utility easement for a future greenway.

Since the July 18 meeting, staff has made significant progress on securing the utility easements as reflected with the removal of the easement line item of \$75,000 in the project budget below. In addition, staff has sent letters to the property owners granting the utility easements requesting an easement for a future greenway. Staff provided an update on the greenway easements for the Director's meeting with no response yet.

The details of the proposed construction contract and project budget from the July 18, 2018 meeting follow:

As directed in the District's approved budget, Mud Creek Interceptor Project was bid on June 19, 2018. As recommended by WGLA Engineering on the attached letter and bid tabulation, Buchanan and Sons, Incorporated is presented to the Board for award of the construction contract. The proposed contract is for \$3,056,970.00.

The project falls within the statutory requirements for a formal bid process and therefore, the Engineer has conducted the bidding accordingly. Additionally, the project was advertised in the local newspaper and posted on the County website.

The proposed budget is as follows:

This project was approved in the FY2019 budget and financed with a contribution from Fletcher Academy of \$1,020,000, the District's fund balance, and a construction loan.

Commissioner Hawkins made the motion to move this agenda item to the August 15, 2018 meeting to allow time to attempt to acquire easements. The motion carried 4-1 with Commissioner Messer voting nay.

Commissioner Hawkins made the motion to adjourn as the Cane Creek Water & Sewer District Board and reconvene as the Henderson County Board of Commissioners. All voted in favor and the motion carried.
