The Henderson County Board of Commissioners met for a regularly scheduled meeting at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

**CALL TO ORDER/WELCOME**

Chairman Edney called the meeting to order and welcomed all in attendance.

**INVOCATION**

The invocation was provided by County Manager Steve Wyatt.

**PLEDGE OF ALLEGIANCE**

The Pledge of Allegiance to the American Flag was led by Boy Scouts of America Troop 610, leader Bud McCall.

Commissioner Tommy Thompson noted a few VIP's in the troop. His son TC Thompson (assistant leader) and grandson Steven Thompson were present along with incoming Commissioner Rebecca McCall's son Bud McCall (leader) and grandson Brock McCall.

**RECOGNITION BY NC ASSOCIATION OF COUNTY COMMISSIONERS AND THE LOCAL FEDERAL GOVERNMENT CREDIT UNION TO THE LIBRARY FOR THE STUDENT ACCESS PROJECT AWARD**

David Nicholson, Outreach Associate from NCACC, and Greta Gibson, Membership Development Officer at the LGFCU, presented the Award to Trina Rushing, Director of the Henderson County Public Libraries. The team included Marcie Dowling, Marketing & Digital Strategy Librarian, and Rick Fender, Chief Technology Officer, Henderson County Public Schools. A check in the amount of \$1,000 was awarded.

The collaboration between Henderson County Public Library and Henderson County Public Schools to automatically provide every public school student with a county library card has resulted in increased access to educational material, cost savings for both systems, and added curriculum flexibility for county teachers and their students. The implementation of the Student Access initiative in Henderson County

created 15,507 electronic public library cards for county public school students. Rather than making sure students keep track of a physical card, they simply provide their student ID number to county library staff to access databases and check out material.

Trina Rushing explained that all public school students now have unfettered access to the county library's collection of 267,576 books and audiobooks. In addition to physical material offered from six county library locations, students and teachers can also access the 96 online databases offered through the county library system. Each of these databases can have annual subscription costs in the thousands of dollars, and being able to access them through the library allows schools to spend their budgets on other resources.

Since starting the Student Access program in October of 2017, the library has seen a significant increase in the usage of children's titles, with the highest increases in the digital audiobook and e-book collections. The Student Access program grants school children access to 268,243 eBooks and digital audiobooks, many of which are simultaneous use titles. This feature allows several students to read and discuss the same book within the classroom setting, and vastly expands the variety of titles available to teachers for literacy instruction.

There was no cost involved in the import and no cost for physical library cards. If the library were to make individual cards for each student, it would require 77,535 staff hours and \$4,497 in library cards. The library has seen a greater return on investment through increased usage of their materials. The combined cost of these subscriptions and collections totals \$70,000 annually. By extending access to county students and teachers, the library's resources are better utilized, the school curriculum is enriched, and the schools expand their accessibility as teachers are able to use the digital copies at no additional cost. Prior to the addition of Student Access cards, these early literacy titles were checked out, on average, 178 times per month. After only six months of Student Access inclusion, the usage jumped to an average of 749 monthly checkouts, an increase of 320% at no additional cost. While this number mixes resident and student cards, it is clear that the introduction of Student Access impacted the increase. Since the initiation of the NC Kids Digital Library collection in October 2017, Henderson County Library cardholders have checked out 5,838 items.

#### **RECOGNITION BY 2018 ASSOCIATION OF NC BOARD OF HEALTH/OUTSTANDING BOARD OF HEALTH IN NC**

Commissioner Lapsley asked the members of the Board of Health in attendance to join him. Present were Bo Caldwell, Patricia Stanley, Jim Crafton, and Robyn Bryson. Commissioner Lapsley stated he participates on the Board of Health on behalf of the Board of Commissioners. It is a privilege to announce to the community that the Henderson County Board of Health has received from the Association of NC Boards of Health the Outstanding Board of Health Award in the State of North Carolina. It is presented for their dedication to community service and their visionary approach to population health by expanding the number of school nurses employed by the Health Department, and the visionary approach to Substance Abuse and Mental Health in our county.

#### **RECOGNITION OF SHERIFF MCDONALD FOR RECEIVING THE LONG LEAF PINE AWARD**

Chairman Edney asked Sheriff McDonald and his wife Jenny to come to the podium. He stated the next item was not on the agenda. In 1985 Charlie McDonald left the US Navy to come to Henderson County and work for our Sheriff's Department. Over the next 25 years he served as a detective, a drug agent, Lieutenant over Training and Career Development, Chief of Investigations, Captain over the Detention Center, Public Information Officer, Internal Affairs Investigator, and a member of SWAT. He is a NC General and Firearms instructor, holds advanced law enforcement advanced service certifications from the Sheriff's Education Training and Standards. He has worked as a contractor instructor for private

companies specializing in law enforcement tactical training as well as serving as an instructor delivering training overseas in South American and the Middle East on Counter Terrorism, Crisis Response, and Tactical Command training and planning. Sheriff McDonald retired in June of 2010 and has a rocking chair from that retirement. The County basically was in crisis and he came back to serve as Sheriff in 2012.

During his tenure as Sheriff, McDonald launched an agency-wide strategic plan with goals focused on utilizing financial and human resources fairly and efficiently, reducing agency targeted crime and enhancing community service. Under his leadership Henderson County breaking and entering was reduced by 41% and part one crimes were reduced 35%. Fair and consistent hiring and promotion processes were created as well as the Sheriff's Leadership Academy to better equip supervisors. Sheriff McDonald made School security a priority with the Adopt-a-School program to increase the number of deputies in the schools, partnered with local stakeholders to improve school security in Henderson County, and was selected to participate in the round tables school security discussion with President Trump. Under his leadership over 6,912 pounds of medications have been collected and safely disposed of as opposed to being on the streets. Other objections during his tenure focused on reducing domestic violence, drug prevention education, and reducing general recidivism.

Sheriff McDonald is married and he and his wife Jenny have four children and five grandchildren.

Commissioner Thompson informed Sheriff McDonald that he has been inducted into the membership of the Long Leaf Pine.

Sheriff McDonald stated he was in attendance, he thought, to present an award. He caught on to something going on about 15 minutes before the meeting started, but was not sure what was going on. It has been an honor for Sheriff McDonald to serve as the Henderson County Sheriff almost seven years. He never planned on being a Sheriff at any time in his life, even as a deputy sheriff. This is a great county to work for and he would be less than honest if he didn't say that any success he has had is truly been on the shoulders and the help of his administrative team, staff, deputies, jailers, etc. They have had folks that have bought in so hard and given so much and continue to do so. The only heartache for him is leaving sooner than he anticipated. He feels he is leaving the county with one of the best Sheriff's Offices instilled in the State of North Carolina, and he believes it will continue to be so. "It's not just about the guy at the top, it's about the quality and caliber of the people that are on board. It's has been a big sacrifice for my wife Jenny, not only for the first 25 years, more specifically this last seven years. Meeting the folks in this agency and the folks of the community who support us has been one of the most humbling experiences of my life." He thanked everyone.

#### **INFORMAL PUBLIC COMMENTS**

1. Bruce Hatfield is working on a volunteer group to assist Bladen County after Hurricane Florence. There are many farmers in that county who have lost their crops and many people have lost their homes. He asked the Board to help with promoting the efforts.
2. Katie Breckheimer spoke in support of greenways. She noted many events have been held on the Oklawaha Trail. She thanked the Board for their support of greenways.
3. Dr. Anne Smith is a Hendersonville Pediatrician. She feels greenways are fabulous and help with childhood diabetes. They provide a safe place for exercise, a great connection for communities, and draw people to Henderson County. She thanked the Board for the feasibility study.
4. Dennis Justice represents Blue Ridge Pickle Ball. He would like for the county to build a dedicated court for Pickle Ball.

**Engineer Selection – Solid Waste Master Plan Update**

As directed by the Board with the approval of the FY19 budget for the Solid Waste Enterprise Fund, Engineering staff solicited engineering firms to update the Solid Waste Master Plan. This will be the first major update of the plan since 2008. The following are items anticipated to be included in the update: transfer station capacity, collections, composting, and financial analysis. Of course, early in the process,

the update team will solicit input from the Board, public, haulers and other stakeholder groups.

In accordance with NC General Statute 143-64.31 (Procurement of Architectural, Engineering, and Surveying Services), staff developed a Request for Qualifications (RFQ) and on August 17, 2018, posted it on the County's website. The responses were received by September 7, 2018, and the following firms submitted Statements of Qualification: Garrett & Moore, Golder Associates NC, McGill Associates, and SCS Engineers. The Statements are available for review in the Engineering Department at the Historic Courthouse.

A detailed review of the firms was conducted based on the criteria established within the RFQ. The selection criteria are as follows: Project Team, Project Experience, Relationships with Funding and Regulatory Agencies, and Customer Service. Based on their Statements and further investigations, staff recommends McGill Associates as the most qualified firm.

Upon the selection by the Board of most qualified firm by the Board of Directors, Engineering staff will negotiate a scope of work and fee for the project and bring the resulting agreement back to the Board for approval.

#### **Engineering Agreement with McGill Associates – Kunz Farm Park Project**

With the selection of McGill Associates as the most qualified responding Engineer for the Kunz Farm Park Project during the Board's August 6, 2018 meeting, staff has negotiated a proposed agreement with McGill for \$24,100, attached. The scope of services is to perform the hydraulic analysis required to construct a pedestrian bridge over the French Board River between Westfeldt and Kunz Farm Parks. This analysis will allow McGill to provide an accurate estimate of the bridges impact on the project's budget and ultimately, the feasibility of accessing Kunz Farm Park via a pedestrian bridge.



We are working hard to change the narrative/perception with our high school students around manufacturing and jobs right here at home. In order to get the volume that we need now and will need in the future, we have to have that pipeline coming from the high schools. Strengthening this partnership and outreach into the high schools is absolutely critical. Because of our efforts over the last year we now have 490 high school students enrolled.

Last year Henderson County generously funded the matching dollars we needed for a Career Coach position. These matching funds allowed us to embed a community college career expert into the high schools. We were only approved for one of these at the state level and she is currently located in East Henderson High and North Henderson High. This has been a tremendous success because that is where our growth is coming from right now. In the future we would like to expand this effort into Hendersonville High and West Henderson High.



The Innovative High School project plays a significant role in our workforce strategy to establish a pipeline of future workers. The Innovative High School prepares workers in mechatronics, firefighting and culinary. In addition we have the Early College where students will earn their high school diploma and Associate's degree in five years – several of these students also enter the workforce upon completion. This was made possible through your vision and from my perspective it was brilliant to build this facility right on the college campus. Yes, innovative and nice facilities matter because now the Innovative High School is seeing a demand in students that want to go there because of the beautiful building.

It is not enough to just tap into high school students but it is equally important that we are getting into the middle schools. If you look at a 6<sup>th</sup> grade middle school kid, in 7 years they are either going into the workforce or into post-secondary education. Connecting with them as early as 6<sup>th</sup> grade to explore possibilities is important. This is our future workforce.


Dr. Chris English stated everything we do is workforce development from college transfer, career technical training, early college and short term training. We are training the local workforce for great jobs in Henderson and Transylvania county from our high school students who are getting ready to hit the workforce, to incumbent workers who need upskill training through our customized training programs. Once such sector that uses our customized training program and is considered a major sector in Henderson and Transylvania is Advanced Manufacturing.

Henderson and Transylvania Counties combined offer some of the most advanced manufacturing processes in the state and employ a vast number of people. Representing over 140 manufacturers in Henderson County and 35 in Transylvania, we provide a trained workforce for such companies as GF Linamar, GE, Elkamet and Kimberly-Clark through advanced training in engineering, machining, welding and most recently hi-pressure die-casting in our South Eastern Advanced Molding Technology Education Center; the only training center of its kind in the United States.

One specific training target for our local manufacturers is to maintain a current workforce. Our manufacturing programs have experienced at 25.8% increase in enrollment since 2015. Specifically our welding program has experienced an 81.3% increase in enrollment since 2015. A part of our economic development strategy includes not only assisting the Henderson County Partnership for Economic Development with the recruitment of businesses, but the retention of the companies we have customized training projects offered at the college allow local industries to use state dollars to invest in incumbent worker training. These are economic dev training incentives offered by the college/State of NC. In 2017-

18 the college completed over 14 major customized training projects in Henderson county with a total value savings to the companies of nearly ¾ of a million dollars. This allowed companies to invest their dollars in regulatory and compliance updates, to align high potential employees to move into leadership roles, and for the expansion of local facilities. Some of these investments include companies such as:

- Selee
- Meritor
- Borg Warner Thermal
- Daystar Technologies
- Lassonde Pappas
- Norafin



Another strong local sector of training and a high need area of employment is Healthcare.


BRCC serves three hospitals: Pardee, Park Ridge Health and Transylvania Regional along with the medical community that surrounds each of these hospitals. The Health Sciences Center, a result of your vision and a significant partnership, now aligns college course work where students can gain real world experiences with onsite clinical work; all in one setting. Since the opening of our Health Science Center we have seen an increase of 8.3% in enrollment in these programs. With local partnerships like those in the new Health Sciences Center, the college is preparing students to transfer to a four year institution or meet the demands of a workforce with immediate employment with a two year degree.



## Public Safety




Partners such as Pardee, Park Ridge, Mission and other healthcare providers can now take advantage of a workforce that has had training in the latest medical technology from EKG Technician to Nursing. All of these programs are experiencing exponential growth especially those in nursing with enrollment of (need enrollment numbers). Also, local students who want to become a pharmacist can go through BRCC and then straight into the Doctor of Pharmacy program at Wingate in this building.



### Getting our workforce Job Ready



Our public safety training is meeting the demands of our local municipalities for a skilled workforce that can ensure the safety of our community. Training in Law enforcement, EMS and Fire protection to name a few, give students the ability to earn credentials and state licensure that leads to immediate employment in this high demand field. In the past year, the college has seen a record number of enrollment in our Basic Law Enforcement Training program. For example, this fall we have over 25 students ready to complete the final stages of training and take state exams and we will hold a second training session this January for a new set of students. Our fire departments continue to tell us they need firefighters. We have all recently experienced and continue to worry about the impact on North Carolina by Hurricane Florence. The first responders that respond to disasters such as this are trained by community colleges. Until something like this occurs you don't have a real appreciation for the value of the training that we do on the public safety side. You don't need them until you need them and then it becomes a life-saving matter.



With over 100 technical programs offering degrees, diplomas and certificates, such as automotive system, business administration, engineering and college transfer, the college is developing the next educated workforce in Henderson and Transylvania county. Our increased growth at the college in our high school programs and degree seeking students, allow these students to take advantage of Programs like work-based learning. This past year we had 76 WBL student who were placed at 69 companies. This on the job training allows students to gain real world experience while still in college and gives students ample time to hone their skills and gain fulltime employment upon graduation.


Students can apply skills learned through advanced training while on the job so workers remain in the county and we can maintain a strong workforce, even when unemployment starts to rise.




Dr. Laura Leatherwood stated a good example of that is our focus on Veteran Recruitment. Recent data shows that there are more than 9400 veterans in Henderson County and 3300 in Transylvania County. While not all of them are employable, we feel this is an untapped group for employment opportunities.



Our economic development strategy also includes Small Business Support. We need a diverse economy because when one sector struggles, the other sectors tend to prop up the others. Support for small businesses is a very important part of job creation and retention. We do this through our Small Business Center.

We recently received a \$210,000 grant from ARC to expand the SAMTEC center for plastics injection molding training.

We are adding courses in Masonry, Construction, HVAC, Plumbing and electrical.



That is where we are and where we are headed with workforce development. In January when we present our 4 year plan to you, these economic and workforce initiatives will be tied to our capital and operating budget request. In 2019 Blue Ridge Community College will turn 50 years old.

**OCCUPANCY TAX REVENUES**

Finance Director Samantha Reynolds stated staff is requesting that the Board approve a budget amendment, which serves to record occupancy taxes collected by Henderson County on behalf of the Henderson County Tourism Development Authority (TDA), and the subsequent transmittal of those funds to the TDA. Currently, occupancy taxes are recorded directly in the TDA fund, but per the external auditors, occupancy tax revenues should be budgeted and recorded in the County’s general fund and then transmitted to the TDA.

*Commissioner Hawkins made the motion that the Board approves the budget amendment to appropriate revenues and expenditures for FY2019 occupancy taxes. All voted in favor and the motion carried.*

**COUNTY MANAGER'S REPORT**

County Manager Steve Wyatt stated Bruce Hatfield had discussed with him and Jimmie Brissie the need for a safe drop off location and county assistance in getting the word out about the volunteer group. Staff will put the information on social media and our website if the Board approves.

*It was consensus of the Board to allow staff to assist with getting the word out to our community by use of social media and the County website.*







**NOW THEREFORE BE IT RESOLVED**, by the Henderson County Board of Commissioners as follows:


1. The radios itemized on the attached Exhibit B are hereby declared to be surplus property.


